

CAP. XXXIII.

An act to change the limits of the village of Arthabaskaville.

[Assented to 12th July, 1888.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. That portion of the municipality of the village of Arthabaskaville, to the south-west of Nicolet River is detached from the said municipality, as well as the portion situated in the fifth range of the township of Arthabaska which formed part thereof; and for that purpose the provisions of the acts 22 Victoria, chapter 108, and 27-28 Victoria, chapter 65, which refer to the aforesaid limits, are hereby repealed.

Certain territory detached from village of Arthabaskaville.

2. The portions detached as aforesaid from the said municipality of the village of Arthabaskaville shall be united and form part of the municipality of the parish of St. Christophe, in the county of Arthabaska, for all municipal and school purposes and all other purposes whatsoever.

Detached territory annexed to St. Christophe.

3. Articles 81 and 82 of the Municipal Code of the Province of Quebec shall apply to the division and payment of the debts, obligations and claims now due by the said municipality of the village of Arthabaskaville, and the taxes therefor shall be levied as if this act did not exist.

M. C. 81 and 82 to apply to division of debts, &c.

4. This act shall come into force on the day of its sanction.

CAP. XXXIV.

An Act to erect the townships of Guigues, Duhamel and Laverlochère, in the county of Pontiac, into one municipality with the powers of a county council.

[Assented to 12th July, 1888.]

WHEREAS it is expedient to constitute the townships of Guigues, Duhamel and Laverlochère, into one municipality, with the powers of a county council ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The townships of Guigues, Duhamel and Laverlochère, in the county of Pontiac, shall form one municipality with the powers of a county council under the operation of the Municipal Code.

Name.

2. The name of the said municipality shall be "The municipality of Temiscamingue."

3. The place of sitting of the council of said municipality shall be at "Priests' Bay."

An act to detach the township of Hereford and a part of the township of Clifton from the county of Compton, and to annex them to the county of Stanstead for judicial purposes and to the registration division of Coaticook for registration purposes.

[Assented to 12th July, 1888.]

Preamble.

WHEREAS the village of Cookshire, chef-lieu of the county of Compton, is situate at a great distance from the said townships of Hereford and Clifton; whereas the inhabitants of the said township of Hereford and part of Clifton are put to great and expensive inconvenience in being obliged to go to Cookshire, a small village, for judicial and registration purposes;

Whereas the town of Coaticook is situate in the adjoining county of Stanstead, at a short distance from the said townships of Hereford and Clifton, and is a town of considerable importance, where the inhabitants of the said townships do all their trading and business generally;

Whereas it would be advantageous and even necessary for the interests and welfare of the said inhabitants to unite the said township of Hereford and a part of the township of Clifton, to the county of Stanstead for judicial purposes and to the registration division of Coaticook for registration purposes; and whereas the inhabitants of the said townships have petitioned for such annexation; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:
