

## CAP. XLII.

An Act to amend article 81 of the Notarial Code.

[Assented to 12th July, 1888].

**H**ER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

**1.** Article 81 of the Notarial Code is amended by adding <sup>46 V., c. 32,</sup> after the words "with the consent of his widow" "in the <sup>s. 81 amended.</sup> fifth line, the words" under whatever system she was married, and whether she has accepted or renounced the community."

**2.** This act shall come into force on the day of its <sup>Coming into</sup> sanction. <sup>force.</sup>

## CAP. XLIII.

An Act to amend the Act 49-50 Victoria, chapter 33, respecting those candidates for the study and practice of the liberal professions who took part in the North-West expedition of 1885.

[Assented to 12th July, 1888.]

**W**HEREAS by the Act 49-50 Victoria, chapter 33, Her <sup>Preamble.</sup> Majesty, by and with the advice and consent of the Legislature of Quebec, was pleased to come to the assistance of those candidates for the study and practice of the liberal professions who took part in the North-West expedition of 1885, and who were qualifical from their classical studies to undergo such examination, by exempting them from the prescribed examinations; and whereas the said act is of no use to the candidates for study, owing to their being unable to comply with one of the conditions imposed by the said act, and whereas it is expedient and just that the said act should have its full and complete effect;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

**1.** Section 1 of the act 49-50 Victoria, chapter 33, is <sup>49-50 V., c. 33,</sup> amended by striking out the words, in the eighth and <sup>s. 1, amended.</sup> ninth lines thereof "that he commenced studying in the autumn of 1885, and";

And by adding after the word "law," at the end of the said section, the following words "and that he establishes that he really intended to study such profession."

## C A P. X L I V .

An Act to amend chapter 18 of the Consolidated Statutes for Lower Canada.

[Assented to 12th July, 1888.]

**H**ER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** Subsection 1 of section 44 of chapter 18 of the Consolidated Statutes for Lower Canada, is replaced by the following :

Provision of

"44. The provisions of this act apply to missions and parishes canonically erected, and administered by a priest, and having boundaries fixed and determined by the religious authorities absolutely in the same manner as they apply to parishes canonically and civilly erected, especially for that which relates to the construction and repair of churches, presbyteries, cemeteries and other dependencies of churches, notwithstanding any provisions subject to a contrary or equivocal interpretation.

Nevertheless, whenever any lot of land or immoveable property has already been taxed in the hands of the same proprietor for an edifice for religious purposes in another parish or mission of which such lot of land or immoveable then formed part, the commissioners, upon petition of the proprietor, and having regard to all the circumstances, shall exempt such lot of land or immoveable property from the whole or part of the taxes in the new mission and order, if necessary, that the sum so deducted be apportioned upon the other immoveable property comprised in the act of assessment"

**2.** This act shall come into force on the day of its sanction.
