## CAP. XLIX.

An Act to amend the act 48 Victoria, chapter 32, respecting the protection of the life and health of persons employed in factories.

[Assented to 12th July, 1888.]

HER Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

**1.** Section 2 of the act 48 Victoria, chapter 32, is amended by striking out, in the proviso of the first paragraph of the said section, the words after "provided that" in the first line to the words "and that" in the third line thereof.

**2.** Section 7 of the said act is amended by adding after paragraph 4 thereof the following:

"4a. The boilers must be kept in good order, and the employer must furnish yearly to the inspector a certificate of their inspection by a competent person."

## CAP. L.

An Act to amend the act 49-50 Victoria, chapter 74, respecting the employment of combustible gases in this Province.

[Assented to 12th July, 1888.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. Section 1 of the act 49-50 Victoria, chapter 74, is amended by replacing the word "ten" in the eighth line thereof by the words "fifteen."

## CAP. LI.

An Act to amend the act 36 Victoria, chapter 25, respecting certain Joint Stock Companies.

[Assented to 12th July, 1888.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 2 of the act 36 Victoria, chapter 25, is amended by adding after the words "United States of America" in the second line thereof the words "or in Canada."

## CAP. LII.

An act to further amend the act of the former Province of Canada, 12 Victoria, chapter 143, respecting the Oblate Fathers.

[Assented to 12th July, 1888.]

WHEREAS the Reverend *Pères Oblats de l'Immaculée Conception de Marie* have, by their petition, represented that it is expedient to further amend the act of the former Province of Canada, 12 Victoria, chapter 143, by which they were incorporated ; and whereas it is expedient to grant such prayer ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 1 of the act, 12 Victoria, chapter 143, is amended by striking out the words "born or naturalized subjects of Her Majesty" in the seventeenth line thereof, and also by striking out the following words : "and the service of any summons or process made at the domicile of any one of the said members of the corporation in any one of their establishments wherein two or more of the said members may reside, shall be a valid service thereof upon the corporation," and also by adding at the end of the said first section, the following :

"The principal establishment of the said corporation in the Province of Quebec is in the city of Montreal."
