C A P. C X X V I I .

An Act to grant a remuneration to the testamentary executors of the estate of the late John Pratt.

[Assented to 12th July, 1888.]

WHEREAS it has been represented by the parties interested that, owing to the importance of the estate of the late John Pratt and in order to secure a proper administration thereof, it is necessary to grant a remuneration to the testamentary executors of the said late John Pratt; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows : Preamble.

1. A remuneration of one thousand dollars, to be taken from and out of the revenues of the estate of the late John Pratt, shall be paid annually to his testamentary executors for their services as administrators of the said estate. Executors estate J. Pratt may receive a certain remuneration.

2. This act shall come into force on the day of its sanction. Coming into force.

C A P. C X X V I I I .

An Act to authorize the Bar of the Province of Quebec of admit Edouard Honoré Tellier among its members, after examination.

WHEREAS Edouard Honoré Tellier, of Three Rivers, in the district of Three Rivers, has received a complete classical education, whereas he was prevented, by special reasons, from presenting himself for examination in order Preamble.

to be admitted to the study of the legal profession, but has studied law for four years ; and whereas his not having been regularly admitted to study exposes him to lose the benefit of several years of legal studies, and whereas the Council of the Bar of Three Rivers has unanimously approved and sanctioned the petitioner's application ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Bar of the Province of Quebec may admit Edouard Honoré Tellier among its members and authorize him to practise the profession of advocate, so soon as he shall have passed the examination required by the act respecting the Bar of the Province of Quebec.

C A P . C X X I X .

An Act to regularize the clerkship of Théophile Alexandre *alias* Alexandre Archambeault, physician, of the parish of St. Paul l'Érmité, in the county of l'Assomption.

[Assented to 12th July, 1888.]

Preamble.

WHEREAS Theophile Alexandre Archambault has studied medicine, surgery and the science of obstetrics during four consecutive years, from the first of October one thousand eight hundred and eighty-three, and that, during such time and according to law, he has followed the required course of studies, at Montreal, in the school of medicine and surgery, affiliated to the Victoria University of Cobourg, Ontario ;

Whereas he has passed his examinations regularly and successfully and received his diploma as a Doctor in Medicine in the year one thousand eight hundred and eighty-seven ;

Whereas he has received a complete classical education ; and, by error, he had not previously obtained his certificate of admission to the study of medicine and surgery according to law ;

Whereas, for this latter reason, he has been unable to obtain his license to practise medicine ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec shall grant to the said Theophile Alexandre Archambeault a license to practise medicine, surgery and the science of obstetrics.
