

CAP. CXXX.

An Act to regularize the clerkship of Prosper Onezime Lauzon.

[Assented to 12th July, 1888.]

WHEREAS Prosper Onezime Lauzon, of Montreal, has Preamble.
studied medicine since the first September, one thousand eight hundred and eighty-one, and has followed a course of lectures at Montreal on medicine in an incorporated University during the period required by law, and has obtained the diploma of Doctor of Medicine, but, through an error, he did not get his certificate of admission to the study of medicine and Surgery, and has since successfully passed the required examination ; whereas, by such error, he is exposed to lose the benefit of his four years of medical studies, and whereas the College of Physicians and Surgeons, after having been called upon and put in default to express its opinion on the subject, and notified that their silence would be considered as an assent, has not deemed advisable to pronounce its opinion ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Provincial Medical Board may grant a license to the said Prosper Onezime Lauzon, for the practice of License to practise medicine may be issued to P. O. Lauzon on certain conditions. Medicine, Surgery and Obstetrics, upon his complying with the other conditions required.

2. This act shall come into force on the day of its Coming into force. sanction.

CAP. CXXXI.

An Act to authorize Felix Laroche to practise the profession of Medicine and Surgery.

[Assented to 12th July, 1888.]

WHEREAS Felix Laroche, a native of France and a resident of this Province for several years, has studied Preamble.
pharmacy for nine years, under the French law, under which he was admitted to practise the profession of a chemist and druggist, and has also obtained the title of Doctor in Medicine at the Victoria School of Medicine, in Montreal ;

Whereas the College of Physicians and Surgeons of the Province of Quebec did not oppose the passing of this Act, whereas it is meet to grant the request of the said Felix Laroche ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

I. The said Felix Laroche shall be authorized to obtain from the College of Physicians and Surgeons of the Province of Quebec, acting through its governors, the ordinary license, authorizing him to practise Medicine, Surgery and the science of Obstetrics, in this Province, and constituting him a member of such corporation with all the privileges attached to such title, at its next half-yearly meeting following the coming into force of this Act, which shall be on the day of its sanction.

C A P. C X X X I I .

An Act to regularize the clerkship of Aimé Prosper Aquila Pichette and permit the Provincial Medical Board to admit him amongst its members.

[Assented to 12th July, 1888.]

Preamble.

WHEREAS Aimé Prosper Aquila Pichette, of the Town of Nicolet, district of Three Rivers has studied medicine during three years, from the first of September, one thousand eight hundred eighty-four, and he has followed lectures on medicine in an incorporated University at Montreal, but through an error he procured his certificate of admission to the study of Medicine and Surgery only on the twenty-eighth September, one thousand eight hundred and eighty-seven ; whereas, by this informality, he is exposed to lose the benefit of two years of medical studies ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

I. As soon as the said Aimé Prosper Aquila Pichette shall have completed four years of medical studies, dating from the first of September, one thousand eight hundred and eighty-four, the Provincial Medical Board may grant to the said Aimé Prosper Aquila Pichette a license to practise Medicine, Surgery and the Science of Obstetrics, provided he passes the necessary examinations and complies with the other conditions prescribed.
