

C A P. X X X I I.

An Act respecting the leasing of the Peninsula of Manicougan.

[Assented to 21st June, 1886.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. It shall be lawful for the Lieutenant-Governor in Council, on report of the Commissioner of Crown Lands, to authorize the said Commissioner to lease, to any person or corporation, for any and all purposes, the whole or any part of that portion of ungranted and unoccupied territory in the Province known as the Manicougan Peninsula, not exceeding forty-five square miles, and the beach surrounding the same, for a period of ten years or less, either at a fixed rental or at a percentage of the net proceeds derived by the lessees therefrom, if the territory so leased is used for manufacturing or commercial purposes ; such lease in no way to interfere with the rights of actual occupants, and to be subject to such other terms and conditions as may be imposed.

Commissioner of Crown Lands may lease certain part of Manicougan Peninsula.

2. This act shall come into force on the day of its sanction.

Coming into force.

C A P. X X X I I I.

An Act respecting those candidates for the study and practice of the liberal professions who took part in the North-West Expedition of 1885.

[Assented to 21st June, 1886.]

WHEREAS a certain number of candidates for the study and practice of the liberal professions took part in the North-West Expedition of 1885 ; that their military services in such expedition have prevented some from presenting themselves at the prescribed time for admission to study and interrupted the studies of others, and whereas it is just to provide that their having taken part in such expedition should not prejudice such candidates ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Preamble.

1. Every aspirant for the study of a liberal profession who performed military duty in the North-West Expedition of 1885, shall be deemed to have passed the examinations

Certain persons exempt from passing examinations

for admission to study. for admission to study held in 1885, and may, at the time prescribed by law, present himself for examination for admission to practise his intended profession, as if he had received a certificate of admission to study and had been under indentures since the spring of 1885, provided that he commenced studying in the autumn of 1885, that there be no other irregularity in his studies, and that he has otherwise complied with the requirements of the law.

Proviso.

Certain students allowed to present themselves for examination although studies have been interrupted. **2.** Every student of a liberal profession, who was under indentures at the time he entered service upon the North-West Expedition of 1885, and who otherwise fulfilled the conditions required by law for admission to such profession, may be admitted to the examination for the practice of such profession as if he had not interrupted his studies for the said expedition, and, if he passes such examination, he shall have a right to be admitted to practise such profession.

Coming into force. **3.** This act shall come into force on the day of its sanction.

CAP. XXXIV.

An Act respecting the Bar of the Province of Quebec.

[Assented to 21st June, 1886.]

Preamble. **W**HEREAS the general council of the Bar of the Province of Quebec has, by petition, prayed that the law respecting the Bar of the Province of Quebec be amended, and it is expedient to grant its prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

SECTION FIRST.

GENERAL PROVISIONS.

§ 1.—*General Corporation of the Bar.*

Certain persons constituted into a corporation. **1.** Under the name of "The Bar of the Province of Quebec," the advocates, barristers, counsel, attorneys, solicitors and proctors-at-law of the province, who, in this act, are designated by the general name of advocates, form a corporation herein called by the short title of "the general corporation of the Bar."
