

numbers 24, 25, 26, 27 and 28 of the sixth and seventh ranges of the township of Weedon, including within the said limits the unoccupied remainder of the said lots Nos. 24, 25, 26, 27 and 28 of the said sixth range of Weedon, situate on the north-east side of the river St. Francis, and bounded by the township of Garthby.

2. All the provisions of the Municipal Code and of the acts amending the same, relating to village municipalities established under such code, shall apply to the municipality of the village of Lake Weedon, except that the first municipal election shall be held on the fifth day of the month of July next (1886), and that a second general election shall be held on the second Monday of January next, and that the subsequent ordinary elections shall be held on the latter date, and the drawing of lots for the councilors who are to go out of office shall take place in the month of December in every year.

Application of Municipal Code thereto.

Exception as to certain elections.

3. Nothing in this act contained shall be considered as relieving that portion of the parish of St. Janvier de Weedon, hereby erected into a village municipality, from the liabilities contracted to date by the municipality of the township of Weedon.

Present liabilities not to be affected.

4. All the bridges, by-roads and roads, situated within the limits of the said municipality of the village of Lake Weedon, shall be at the charges of the latter and under its exclusive control.

Bridges, &c., to be at charges of municipality.

5. This act shall come into force on the day of its sanction.

CAP. LVI.

An Act to divide the municipality of the township of Templeton, in the county of Ottawa, into two separate municipalities.

[Assented to 21st June, 1886.]

WHEREAS a large number of the inhabitants of the township of Templeton, in the county of Ottawa, have prayed, by petition, that the township be erected into two distinct and separate municipalities, and it is expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Preamble.

1. The municipality of the township of Templeton shall cease, in future, to form only one municipality and shall be divided into two distinct municipalities, which will be

Names of municipalities. known and designated as follows : " The municipality of Templeton West," and " The municipality of Templeton East".

Description of territory comprised in Templeton West.

2. The municipality of Templeton West shall comprise, in future, all that portion of the township contained in the following limits, that is to say : starting from a point on the Ottawa river at the intersection of the line of division between the lots fourteen and fifteen of the first range of the said township ; thence, on a line running towards the north and following the line of division of lots fourteen and fifteen of the first, second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth, eleventh, twelfth and thirteenth ranges, and between the lots twenty-eight and twenty-nine of the Gore of Templeton, to the line of division between the townships of Templeton and Portland ; thence, running towards the west on the said line, to the eastern limit of the township of Wakefield ; thence, running towards the south, to the northern limit of lot twenty-three B of the said township of Templeton ; thence towards the south, following the line of division between the townships of Hull and Templeton to the northern limit of the village of Gatineau Point ; thence, towards the east, following the northern limit of the village of Gatineau Point to the line of division between lots twenty six and twenty-seven of the second range of said township ; thence towards the south, following the line of division between the said village of Gatineau Point and lot twenty-six B, of the said second range, to the south-west corner of said lot twenty-six B ; thence towards the east, following the said line of division between the said village of Gatineau Point, and lots twenty-three, twenty-four, twenty-five and twenty-six of the said second range to lot twenty-two of the same range ; thence towards the south, following the line of division between the village of Gatineau Point and lot twenty-two of the first range of the said township of Templeton to the Ottawa river ; thence towards the east, following the Ottawa river with the current, and including in the present limits the island known as Kettle Island, to the starting point.

Id. Templeton East.

The municipality of Templeton East shall comprise the remaining territory of the old municipality.

To be separate municipalities.

3. These two municipalities respectively so erected shall be separated and distinct for all municipal and school purposes ; and all the provisions of the Municipal Code shall apply to these municipalities, also to the corporation and to the council of each of them, as if they had been separated in virtue of that code.

Application of Municipal Code.

4. A meeting of the qualified electors of the said municipality of Templeton West shall be held, in the said municipality, on the first Monday of the month of February, one thousand eight hundred and eighty-seven, for the election of councillors, and in accordance with the provisions of the Municipal Code ; and the municipal councillors of the present township of Templeton shall remain in office for the said municipality of Templeton East, with the exception of those who retire and of those who do not reside within its limits.

5. A meeting of the qualified electors of the said municipality of Templeton West shall be held on the second Monday of the month of March, one thousand eight hundred and eighty-seven, for the election of school commissioners, in conformity with the law.

6. The moveable property, liabilities and assets of the present municipality of the township of Templeton, shall be divided between the two new municipalities in conformity with the Municipal Code.

CAP. LVII.

An Act to better define the limits the parish of of " Les Saints Anges de Lachine."

[Assented to 21st June, 1886.]

WHEREAS it has become necessary to establish in a more precise manner the boundaries between the parish of Les Saints Anges de Lachine and those of Saint Laurent, in the county of Jacques Cartier, in the district of Montreal ; considering the *procès-verbal* of the Reverend Hypolite Moreau, canon of the Cathedral of Montreal, special commissioner of the administrator of the diocese of Montreal, bearing date the twenty-seventh of April, one thousand eight hundred and seventy, recommending the change hereinafter mentioned ; considering the canonical decree of the Reverend A. F. Truteau, administrator of the diocese of Montreal, bearing date the twelfth of May, one thousand eight hundred and seventy, ordering the change hereinafter mentioned ; considering the petition of the corporation of the parish of Les Saints Anges de Lachine, praying that such change be confirmed, and whereas it is
