

4. A meeting of the qualified electors of the said municipality of Templeton West shall be held, in the said municipality, on the first Monday of the month of February, one thousand eight hundred and eighty-seven, for the election of councillors, and in accordance with the provisions of the Municipal Code ; and the municipal councillors of the present township of Templeton shall remain in office for the said municipality of Templeton East, with the exception of those who retire and of those who do not reside within its limits.

CAP. LVII.

An Act to better define the limits the parish of of " Les Saints Anges de Lachine."

[Assented to 21st June, 1886.]

WHEREAS it has become necessary to establish in a more precise manner the boundaries between the parish of Les Saints Anges de Lachine and those of Saint Laurent, in the county of Jacques Cartier, in the district of Montreal ; considering the *procès-verbal* of the Reverend Hypolite Moreau, canon of the Cathedral of Montreal, special commissioner of the administrator of the diocese of Montreal, bearing date the twenty-seventh of April, one thousand eight hundred and seventy, recommending the change hereinafter mentioned ; considering the canonical decree of the Reverend A. F. Truteau, administrator of the diocese of Montreal, bearing date the twelfth of May, one thousand eight hundred and seventy, ordering the change hereinafter mentioned ; considering the petition of the corporation of the parish of Les Saints Anges de Lachine, praying that such change be confirmed, and whereas it is

expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Certain lots to form part of "Les Saints Anges de Lachine."

Previso as to existing rolls, &c., and debts now due, &c.

1. The following lots of land are declared to form part of the parish of "Les Saints Anges de Lachine," in the county of Jacques-Cartier, for all religious, civil, school, municipal, judicial and other purposes whatever, namely:

1. The lots of land known as those of the Côte de Liesse, north, and designated, in the official plan and book of reference of the cadastre of the parish of Saint Laurent, under the numbers five hundred and sixteen, five hundred and seventeen, five hundred and eighteen, five hundred and nineteen, five hundred and twenty, five hundred and twenty-one, five hundred and twenty-two, five hundred and twenty-three, five hundred and twenty-four, five hundred and twenty-five, five hundred and twenty-six, five hundred and twenty-seven, five hundred and twenty-eight, five hundred and twenty-nine, five hundred and thirty, five hundred and thirty-one, five hundred and thirty-two, five hundred and thirty-three, five hundred and thirty-four, five hundred and thirty-five, five hundred and thirty-six, five hundred and thirty-seven, five hundred and thirty-eight, five hundred and thirty-nine, five hundred and forty, five hundred and forty-one, five hundred and forty-two, and five hundred and forty-three, of the parish of Saint Laurent, in the county of Jacques-Cartier;

2. The lots of land of the Côte de Liesse, south, known and designated, in the official plan and book of reference of the cadastre of the parish of Saint Laurent, under the numbers five hundred and forty-four, five hundred and forty-five, five hundred and forty-six, five hundred and forty-seven, five hundred and forty-eight, and five hundred and forty-nine, of the parish of Saint Laurent, in the county of Jacques-Cartier.

2. This act shall be construed as an act declaratory of the King's decree, bearing date the third of March, one thousand seven hundred and twenty-two.

Nevertheless, all valuation rolls, *procès-verbaux*, assessments for the construction or repairing of churches, for municipal or school purposes, as well as all proceedings relating thereto adopted up to this day, and in which the said lands are considered as belonging to St. Laurent, are declared to be and recognized as valid with respect to the amounts due and owing at the time that this act shall come into force only; but the proprietors of land hereby declared to form part of the parish of Les Saints Anges de Lachine shall be free for the future, for all lawful purposes,

of all debts and municipal or school taxes, for the construction or repairing of churches and of the *fabrique* of the parish of St. Laurent.

3. The present act shall not have a retroactive effect. Act not to be retroactive.

4. This act shall come into force on the day of its sanction. Coming into force.

CAP. LVIII.

An Act to extend the limits of the village of La Prairie and to provide for the conceding of new building lots in the Common of the same locality.

[Assented to 21st June, 1886.]

WHEREAS the inhabitants of the village of La Prairie Preamble. have, by petition, represented that it has become necessary to extend the limits of the said village and to provide for the conceding of new building lots in the Common of the said locality ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. From and after the passing of this act, the limits of the village of La Prairie, in the county of La Prairie, shall be extended to the following boundaries : Limits of village of La Prairie extended.

In front to the north-west, the River Saint Lawrence from the north-east line of lot number five hundred and fifty-one (551) on the official plan and book of reference of the parish of La Prairie, to the mouth of the River Saint James ; to the north-east from the river to the north-west line of lot number three hundred and sixteen (316) ; to the south-east, a straight line drawn from the boundary between lots numbers three hundred and fifteen (315) and three hundred and sixteen (316) to the north-east angle of lot number five hundred and fifty-two (552), where the Grande-Coulée road opens on La Prairie Common ; and finally to the south-west, the north-east line of lot number five hundred and fifty-one (551) from the place lastly mentioned to the River Saint-Lawrence. Boundaries of village.

The width required by law for an ordinary public highway, taken outside the south-eastern limits as above described, shall likewise be included in the municipality of the village of La Prairie. Proviso as to certain public road.
