

CAP. LIX.

An Act to define the boundaries of the parish of Sainte Barbe and for other purposes.

[Assented to 21st June, 1886.]

Preamble.

WHEREAS by a proclamation, bearing date the twelfth of June, one thousand eight hundred and eighty two, the parish of Sainte Barbe, in the county of Huntingdon, was erected for civil purposes ;

Whereas the boundaries of the said parish, as set forth in the said proclamation, are different from those mentioned in the canonical decree, inasmuch as the said proclamation comprises a certain territory situate between the second and third ranges of Godmanchester, and such territory is not included in the said decree, and whereas, owing to such error, doubts have arisen as to the real boundaries of the said parish of Sainte Barbe ;

Whereas it is stated in the said proclamation that the said parish of Sainte Barbe shall be bounded on the south-east by the property which shall bear the number nine hundred and fourteen of the official plan and book of reference of the township of Godmanchester ;

Whereas doubts have arisen with reference to the use of a number of a cadastre which is not yet in force ;

Whereas the whole of the territory of the said parish of Sainte Barbe is comprised in the township of Godmanchester ;

Whereas, since its civil erection as aforesaid, the parish of Sainte Barbe has formed itself into a *fabrique* and has exercised the powers and privileges conferred upon parishes by the law respecting public instruction ;

Whereas doubts have arisen as to the legal existence of such parish for school purposes and as to the validity of its acts as a civil parish ; and, in order to remove such doubts, it is expedient to legalize its existence as a civil parish, and all the acts which it has so performed in the exercise of its civil and scholastic powers ;

And whereas it is expedient that the boundaries of the said parish be more clearly defined ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Boundaries of parish of Ste. Barbe.

1. The boundaries and limits of the parish of Sainte Barbe, in the county of Huntingdon, are hereby declared to be and to have been as follows :

“(a) Towards the south-east by the line, which divides the second range from the third range of the township of

Godmanchester, starting from number one of the said township to number seventeen of the same township, inclusively, and by the line which divides the third range from the fourth range of the said township, starting from the said number seventeen to the road called Port Louis Road; on the south-west by the said Port Louis Road; on the north-west by lake Saint Francis, and on the north-east by the south-west line of the seigniory of Beauharnois, which divides the said parish of Sainte Barbe from the parish of Saint Stanislas de Kostka."

2. It is further declared that the said parish of Sainte Barbe possesses and has possessed all civil, and scholastic powers, rights and privileges, and the acts performed by such parish are declared valid, in so far as they are conformable to the statutes and to the laws respecting public instruction.

3. This act shall not affect suits now pending and shall come into force on the day of its sanction.

An Act to incorporate "The Sherbrooke Young Men's Christian Association."

[Assented to 21st June, 1886]

WHEREAS the persons hereinafter named have, by petition, represented that for some years past, they and others have composed and maintained, by voluntary contributions, a certain association in the city of Sherbrooke, known as "the Sherbrooke Young Men's Christian Association," and that the objects of the said association would be better attained if the same were invested with corporate powers; and whereas it is expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:
