

Expelled, &c.,
members for-
feit rights. **10.** Every member expelled from the association, or who may withdraw therefrom, or whose name is struck from the list of members for any of the reasons mentioned in the constitution, rules and by-laws, shall forfeit all the rights which he enjoyed as a member of the association.

Application of
revenues of
corporation. **11.** The rents, revenues and profits, derived from all moveable and immoveable property belonging to the corporation, shall be exclusively affected to and employed for the use of the association, for the construction and repair of the buildings required for the purposes of the association, and for the payment of the expenses lawfully incurred for the objects connected with the aforesaid purposes.

Coming into
force. **12.** This act shall come into force on the day of its sanction.

CAP. LXXIII.

An Act to incorporate the "Licensed Victuallers Association of Quebec."

[Assented to 21st June, 1886.]

Preamble. **W**HEREAS L. Alexander Boisvert, Jacques Belleau, Thomas Potvin, Louis Alphonse Croteau, Cléophas Rousseau, Misaël Thibaudeau, Alfred Grenier, James Burns, Andrew Crawford, J. Elzéar Pâquet, Joseph L. Donnelly, all licensed traders of the city of Quebec, have, by petition, prayed for an act of incorporation under the name of the "Licensed Victuallers Association of Quebec," and to be granted certain powers hereinafter mentioned, and it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Persons incor-
porated. **1.** The persons above-mentioned and others who are already members, and all who may hereafter become members, are constituted a body politic and corporate under the name of the "Licensed Victuallers' Association of Quebec."

Object of asso-
ciation. **2.** The object of the association is to unite all the members thereof into a society, in order to protect their rights as license holders, and to maintain the respectability of the members of the association, and to assist the authorities in suppressing unlicensed establishments and in causing the license law to be respected.

3. The association shall have the right to make rules and regulations for the government and management of its members and the general management of its affairs, in so far as such rules are not inconsistent with the laws of this Province. Power of association to make rules, &c.

The rules and regulations, now in force, shall remain until they be altered. Present rules, &c.

The corporation may, from time to time, amend, repeal and alter such rules and regulations, wholly or in part, as it may deem expedient but in the manner prescribed and followed at present. Power to amend, &c., rules.

4. The affairs of the corporation shall be managed by a president, vice-president, a secretary, a treasurer and a board of directors, composed of six members, elected annually at the general meeting held on the first Thursday of January in each year, according to its rules and regulations, and shall together constitute the board of directors and shall remain in office until the following annual election ; Management of affairs.

All vacancies which may occur in the board of directors, by death or otherwise, shall be filled by the said board of directors according to the rules and regulations. Vacancies in board.

5. L. Alexandre Boisvert, Jacques Belleau, Thomas Potvin, Louis Alphonse Croteau, Cléophas Rousseau, Misaël Thibaudeau, Alfred Grenier, James Burns, Andrew Crawford, J. Elzéar Pâquet and Joseph Donnelly shall form the board of directors, until others are elected in their stead under the provisions of this act. First board of directors.

6. The corporation may, from time to time and at all times, purchase and acquire, hold, take, own and possess, for its use, moveable and immovable property, provided the annual revenue therefrom does not exceed six thousand dollars, and it may hypothecate, sell, alienate and dispose of the same and acquire others in lieu thereof whenever the said corporation shall deem proper. Power to hold, &c., property. Amount limited.

7. No member or officer shall be in any manner responsible or obliged to pay any debt or claim beyond the amount of his unpaid subscription ; and any member of the association, who is not in arrear, may retire therefrom and cease to be a member thereof, by giving notice to that effect, in the manner required by the rules and regulations of the association. Members not responsible for debts, &c. Members may retire.

Every member, who is expelled or who retires from the association, or whose name is struck from the list of members for any of the reasons mentioned in the rules and regulations, shall forfeit all the rights which he enjoyed in his capacity of member of the association. Expelled, &c., members forfeit rights, &c.
