

CAP. XXXVIII.

An Act to amend an Act of this session, intituled: "An Act to erect the parish of St. Joachim de Shefford into a municipality for municipal and school purposes."

[Assented to 10th June, 1884.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

47 V., c. 37, s. 3, amended.

1. Section 3 of the act of this session, intituled: "An Act to erect the parish of St. Joachim de Shefford into a municipality for municipal and school purposes;" is amended by replacing the word "June," in the third line of such section by the word "July."

Coming into force.

2. This act shall come into force on the day of its sanction.

CAP. XXXIX.

An Act to detach a certain portion of the township of Tingwick, in the county of Arthabaska, and to annex it to the municipality of the township of West Chester, for municipal and school purposes.

[Assented to 10th June, 1884.]

Preamble.

WHEREAS, lots numbers 1 and 2 of the 6th and 7th ranges of the township of Tingwick in the parish of St. Patrice de Tingwick, were annexed to the parish of St. Paul of West Chester, for religious purposes, under a decree of Monseigneur Lafèche, bishop of Three Rivers, dated 2nd January, 1879, and recognized as such for civil purposes by proclamation of the Lieutenant Governor, the Honorable Luc Letellier, dated the 19th June, 1879; and whereas, under Order in Council, dated at Quebec on the 27th June, 1879, the said territory was also annexed to the said township of West Chester, for school purposes; Therefore Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Certain parts of Tingwick annexed to West Chester for municipal and school purposes.

1. Lots numbers 1 and 2 of the 6th and 7th ranges of the township of Tingwick, as detached and annexed to the parish of St. Paul de West Chester, for canonical and civil purposes as aforesaid, are hereby declared to be

detached from the township of Tingwick and annexed to the municipality of the township of West Chester, for municipal and school purposes.

C A P. X L.

An Act to detach certain parts of the augmentation of the township of Caxton, from the parish of St. Barnabé, and to annex them to the parish of Ste. Anne d'Yamachiche in the county of St. Maurice, for all purposes whatsoever

[Assented to 10th June, 1884.]

WHEREAS, by the canonical decrees of His Grace Mon^{Preamble.} seigneur Louis François Laffèche, bishop of Three Rivers, dated respectively the 16th July, 1875, and the 2nd May, 1884, hereinafter mentioned, and by the cadastre for enregistrement purposes of the said county of St. Maurice, made by the Honorable the Commissioner of Crown Lands, in force on the 25th August, 1878, as appears by the Quebec Official Gazette of the 20th July, 1878, page 2208, the parts hereinafter mentioned of the said augmentation of the township of Caxton, were detached from the said parish of St. Barnabé, and annexed to the said parish of Ste. Anne d'Yamachiche for religious and registration purposes, from the respective dates of the said decrees and the coming into force of the said cadastre; and it is expedient to establish uniformity for all purposes of the administration of affairs of the said parishes of St. Barnabé and Ste. Anne d'Yamachiche; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. All that part of the territory of the augmentation of the township of Caxton in the parish of St. Barnabé, in the county of St. Maurice, which is bounded to the north-east by the fief St. Etienne, to the north by the north line of the property of Sieur Sévère Gagnon, and by the continuation of the said line to the south-west line of the augmentation of Caxton, and to the south by the south line of the augmentation of the township of Caxton, which was dismembered from the parish of St. Barnabé and annexed to the parish of Ste. Anne d'Yamachiche, for canonical purposes by a decree of His Grace Monseigneur Louis François Laffèche, bishop of Three Rivers, dated the 16th July, 1875; and
