CAP. XL.

An Act to detach certain parts of the augmentation of the township of Caxton, from the parish of St. Barnabé, and to annex them to the parish of Ste. Anne d'Yamachiche in the county of St. Maurice, for all purposes whatsoever

[Assented to 10th June, 1884.]

WHEREAS, by the canonical decrees of His Grace Mon ^{Preamble.} seigneur Louis François Laflèche, bishop of Three Rivers, dated respectively the 16th July, 1875, and the 2nd May, 1884, hereinafter mentioned, and by the cadastre for enregistration purposes of the said county of St. Maurice, made by the Honorable the Commissioner of Crown Lands, in force on the 25th August, 1878, as appears by the Quebec Official Gazette of the 20th July, 1878, page 2208, the parts hereinafter mentioned of the said augmentation of the township of Caxton, were detached from the said parish of St. Barnabé, and annexed to the said parish of Ste. Anne d'Yamachiche for religious and registration purposes, from the respective dates of the said decrees and the coming into force of the said cadastre; and it is expedient to establish uniformity for all purposes of the administration of affairs of the said parishes of St. Barnabé and Ste. Anne d'Yamachiche; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. All that part of the territory of the augmentation of the township of Caxton, in the parish of St. Barnabé, in the county of St. Maurice, which is bounded to the north-east by the fief St. Etienne, to the north by the north line of the property of Sieur Sévère Gagnon, and by the continuation of the said line to the south-west line of the augmentation of Caxton, and to the south by the south line of the augmentation of the township of Caxton, which was dismembered from the parish of St. Barnabé and annexed to the parish of Ste. Anne d'Yamachiche, for canonical purposes by a decree of His Grace Monseigneur Louis François Laflèche, bishop of Three Rivers, dated the 16th July, 1875; and

Certain part of augmentation of Caxton, in parish of St. Barnabé, for canonical purposes,

And of augmentation of Caxton, in parish of Ste. Anne d'Yamachiche, for registration purposes,

2. All that part of the territory of the said augmentation of the township of Caxton, in the said parish of St. Barnabé, which, according to the official cadastral plan for registration purposes of the said parish of Ste. Anne d'Yamachiche, in the county of St. Maurice, which came into force on the twenty-fifth of August, eighteen hundred and seventy-eight, is included in the said parish of Ste. Anne d'Yamachiche for registration purposes, and is designated on the said cadastre for the said parish of Ste. Anne d'Yamachiche, under the numbers and name of proprietors and holders as follows, to wit : No. 382, Grégoire Aubry ; No. 383, Evariste Garceau ; No. 384, Antoine Lamothe ; No. 385*a*, Louis Léon Lesieur Desaulniers, and No. 385*b*, Louis and Augustin Gignac, which was also dismembered for religious purposes from the said parish of St. Barnabé and annexed to the said parish of Ste. Anne d'Yamachiche, by canonical decree of His Grace Monseigneur Louis François Lafleche, bishop of Three Rivers, dated the second of May, eighteen hundred and eighty-four, so as to make the division lines of the canonical parishes of St. Barnabé and Ste. Anne d'Yamachiche coincide with those established by the cadastral plan for registration purposes,

Annexed to parish of Ste. Anne d'Yamachiche, for all purposes.

Are hereby declared to be detached from the said parish of St. Barnabé and annexed to the said parish of Ste. Anne d'Yamachiche for all purposes whatsoever.

Coming into force.

2. This act shall come into force on the day of its sanction.

CAP. XLI.

An Act to remove certain doubts respecting the act 44-45 Victoria, chapter 32 respecting the annexation to the municipality of the united townships of Stoneham and Tewkesbury of a certain part of the parish of St. Edmond de Stoneham.

Preamble.

WHEREAS doubts have arisen respecting the annexation of the school municipality of Roche Platte which formed part of the territory annexed to the municipality of the united townships of Stoneham and Tewkesbury, in the county of Quebec, by the act 44-45 Victoria, chapter 32, and it is expedient to remove such doubts ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, declares and enacts as follows :
