

C A P . X L I I I .

An Act to erect the parish of St. Anastasia de Nelson, into a separate municipality.

[Assented to 27th May, 1882.]

Preamble.

WHEREAS the inhabitants of the parish of St. Anastasia de Nelson and certain others, inhabitants of the township of Nelson, have petitioned to be erected into a separate municipality ; and whereas by law the county council of the county of Megantic have not the power to erect such separate municipality, and whereas it is expedient to grant the prayer of the said petition ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Part of parish of St. Anastasia de Nelson declared to be separate municipality.

1. The parish of St. Anastasia de Nelson, such as it is described in the proclamation of the lieutenant governor of the province of Quebec, bearing date the twenty fifth December, one thousand eight hundred and seventy seven, except however so much thereof as is included in the township of Inverness to the south-west of the river Becancour, together with the ninth and tenth ranges of the township of Nelson, is hereby erected into a separate municipality, together with all the powers of a municipality as constituted by the municipal code of this province.

Commencement of powers of municipality.

2. The powers of the said municipality shall commence on the first day of January next.

C A P . X L I V .

An Act to detach from the parish of Varennes, county of Verchères, three islands in the River Saint Lawrence and to annex the same to the parish of Repentigny, County of L'Assomption, for electoral, municipal, scholastic and other purposes.

[Assented to 1st May, 1882.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Certain islands detached from the parish and county of Varennes and an-

1. The following three islands, situate in the River Saint Lawrence, near the territory of the parish of Repentigny, to wit : the *Ile à l'Aigle*, comprising an area of about one hundred and fifty arpents ; the *Ile au Cerfeuil*, comprising

an area of about sixty arpents, and the *Ile au Bois Blanc*, nexed to parish of Repentigny, county of Assomption. comprising an area of about fifteen arpents, together with the islets adjacent thereto, are hereby declared to be detached from the parish of Varennes, in the County of Verchères, and to be annexed to the parish of Repentigny, in the County of L'Assomption, for electoral, municipal, scholastic, judicial and registration purposes.

2. The present Act shall not affect any collection roll, Collection roll of parish of Varennes not affected. now in force in the said parish of Varennes.

C A P . X L V .

An Act to establish the position and extent of certain ranges in the township of Tring.

[Assented to 27th May, 1882.]

WHEREAS difficulties have arisen in relation to the Preamble. true extent and position of part of the first range of the township of Tring, in the county of Beauce; and whereas it is expedient that all doubts be removed in respect to the said range; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. The tract of land, lying between the 2nd range of the township of Tring and the north-east outline of the said township, from lot No. 22 to lot No. 28 inclusive, is divided into two ranges, namely: Range A and the first range; the same being severally described as follows: Position and extent of certain ranges in Tring defined.

The first range includes seven lots, numbered from south-east to north-west, namely, from lot No. 22 to lot No. 23, inclusive; the said lots being bounded to the south-west by the lands of range A, and comprising the cadastral numbers from No. 61 to No. 87, inclusive.

Range A, bounded to the north-east by the lands of the first range, to the south-west by the lands of the second range, to the north-west by the line of the township of Broughton, and to the south-east by the north-west side line of the lot No. 27 in the second range. The said range A comprising the cadastral numbers from No. 253 to No. 266, inclusive; and the first range being thus limited to the south-west by the line dividing the cadastral numbers 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 86, and 87, all in the said first range, from the cadastral numbers 253, 255, 256, 257, 258, 259, 260, 261, 262, 263, 264, 265 and 266, all
