

was incorporated by an Act of the Parliament of the late Province of Canada, passed in the 10th and 11th years of Her Majesty's reign, Chapter 69, and that, by section 14 of the said Act, it was provided that the principal place of business of the said Association should be in the city of Quebec, and that it is expedient that the said principal place of business of the said Association should be removed to the city of Montreal; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Principal place of business of the association. 1. The principal place of business of the Quebec and Lake Superior Mining Association shall henceforward be in the City of Montreal.

10-11 Vict., cap. 69 amended. 2. The Act, 10th and 11th Victoria, Chapter 69, is amended by substituting the word "Montreal" for the word "Quebec" wherever mention is made in the same of the principal place of business of the said Association.

An Act to change the name of "The Lawlor Manufacturing Company," into that of the "Belmont Manufacturing Company."

[Assented to 1st May, 1882.]

Preamble.

WHEREAS, on or about the twenty seventh of March, one thousand eight hundred and eighty, "The Lawlor Manufacturing Company" was duly constituted a body corporate and politic, by letters-patent under "An Act respecting the incorporation of joint stock companies" passed by the Legislature of Quebec in the thirty first year of Her Majesty's Reign;

And whereas it has been represented that the said name of the said company now conflicts with the names of certain commercial partnerships and is a hindrance to the business success of the said company;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:—

New name of company. 1. Henceforth the corporate name of the said company shall be the "Belmont Manufacturing Company."

General powers. 2. In future, the said company shall be a body corporate and politic, under the name of the "Belmont Manufacturing Company", and, under that name, may sue

and be sued, in respect of any causes of actions, claims or demands which may have accrued to the said company, or for which it may be responsible, as having carried on business, in virtue of the said letters-patent, under the name of "The Lawlor Manufacturing Company;" and the change of name hereby authorized will not affect pending cases. Pending cases not affected.

C A P . L X X V I .

An act to amend the act incorporating the French-Canadian Artizans' Society of the city of Montreal. (40 Victoria, chapter 63.)

[Assented to 27th May, 1882.]

WHEREAS the French-Canadian Artizans' Society of Preamble. the city of Montreal has, by its petition, prayed for certain amendments to its charter, and it is expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. Section 2 of the act of this province 40 Victoria, 40 Vict., cap. 63, sec. 2 amended. chapter 63, is amended, by adding after the word: "society" in the eighth line, the words: "who are present."

2. Section 4 of the said act is amended, by adding Idem sec. 4 amended. in the fourth line after the words: "for three years" the words: "except two of those who shall be elected at the first annual meeting, one of whom shall remain in office for two years and the other for one year.

Every year thereafter, the censors who retire after three years of office, shall be replaced at the general meeting."

The said section 4 is further amended, by striking out the words: "and shall" in the said fourth line, and replacing them by the words: "the duties of the said censors shall be to."

3. Section 5 of the said act is amended, by adding, in Idem sec. 5 amended. the second line of the second paragraph after the word: "society," the word: "present."

4. This act shall come into force on the day of its Act in force. sanction.
