An Act to incorporate "*L'Orphélinat de Marieville.*"

[*Assen'ed to 1st May, 1882.*]

Preamble.

WHEREAS the Reverend François Xavier Jeannotte, parish priest, Alexis Bouvier, Delphis Meunier and Pierre Saurette, priests, the Reverend Sisters St. Michel and Dion, Sisters of Charity, Jacques Franchère, M.D., Joseph Archambeault, François Xavier Girard, Zéphirin Bedard and Jeremie Théberge, all of the parish of Ste. Marie de Monnoir, have, by their petition, prayed for the incorporation of the orphan asylum, which has existed for eighteen years at Marieville under the name of "*L'Orphélinat de Marieville,*" and it is expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Certain persons incorporated.

1. The parish priest and the first churchwarden in office of the parish of Ste. Marie de Monnoir and their successors for ever, the director of Le Petit Séminaire de Ste. Marie de Monnoir and his successors for ever, the Reverend Sister Superior and the treasurer (*dépositaire*) of L'Hospice Ste. Croix de Ste. Marie de Monnoir and their successors for ever, shall be the directors of the said orphan asylum, and shall be a corporation under the name of "*L'Orphélinat de Marieville,*" and, as such, shall have the rights and powers appertaining to corporations and may acquire and possess such real estate as may be requisite and necessary for the purposes of the said orphan asylum and may alienate, sell, grant, lease, and otherwise dispose of the same or any part thereof, from time to time, and as occasion may offer, and acquire others in lieu thereof, and the said corporation may acquire all other immovable property, or interest therein by gift, legacy or inheritance, and dispose of the same for the purposes of the said orphan asylum; provided the annual value of the whole of the said immovable property shall not exceed the sum of ten thousand dollars and the said corporation may also, from time to time, make such regulations and by-laws for the internal management and government of the said orphan asylum, as to them may seem meet and expedient; and three of the said directors shall form a quorum for the transaction of business.

Appointment and removal of secretary.

2. The Corporation, under the name aforesaid, may appoint a secretary or manager and remove him at

pleasure, and appoint another in his stead and it shall annually submit a statement of its affairs, before both Houses of the Legislature, within the first fifteen days from the opening of each session. Return to Legislature.

3. The said Corporation shall constitute a board and may elect one of its members as president, who, whenever the votes are equally divided, shall have a casting vote. Constitution of the board and power of president.

4. All proceedings before any court in this province, respecting any matter or thing, connected with the said Orphan Asylum, shall be served upon the secretary or manager or at the office of the said corporation; and the said secretary or manager is hereby authorized to affix the seal of the said corporation to any deed or deeds, title or titles, requiring such seal to be affixed. Services upon corporation. Secretary empowered to affix seal to deeds &c.

5. The said Corporation may borrow such sum of money, as it may deem advisable for the purposes aforesaid, provided such loans shall not exceed, in the aggregate, twenty thousand dollars, and it may hypothecate the immovable property of the said orphan asylum as security for the repayment of the said loans and of the interest thereon. Power to borrow money up to a certain sum.

C A P . X C V .

An Act to incorporate "*La Trappe de Notre-Dame du Lac des Deux Montagnes.*"

[Assented to 1st May, 1882.]

WHEREAS the religious trappists of the Lake of Two Mountains, to wit: Fr. M. Guillaume, prior; Fr. M. Jean-Baptiste, priest, cellarer; Fr. M. Alban, priest, and Fr. M. Louis de Gonzague, priest, have, by their petition, represented that they have founded an establishment at the Lake of Two Mountains, in the district of Terrebonne, for the purpose of devoting themselves to agriculture and to teaching it, both in theory and practice; Preamble.

Whereas, already through the generosity of the Seminary of St. Sulpice, of Montreal, they possess, at the Lake of Two Mountains, farms which they are beginning to work, and which they intend to improve, so as to make model farms at which young men may be taught agriculture and stock-raising, and improve themselves in the knowledge thereof;
