

pleasure, and appoint another in his stead and it shall annually submit a statement of its affairs, before both Houses of the Legislature, within the first fifteen days from the opening of each session. Return to Legislature.

3. The said Corporation shall constitute a board and may elect one of its members as president, who, whenever the votes are equally divided, shall have a casting vote. Constitution of the board and power of president.

4. All proceedings before any court in this province, respecting any matter or thing, connected with the said Orphan Asylum, shall be served upon the secretary or manager or at the office of the said corporation; and the said secretary or manager is hereby authorized to affix the seal of the said corporation to any deed or deeds, title or titles, requiring such seal to be affixed. Services upon corporation. Secretary empowered to affix seal to deeds &c.

5. The said Corporation may borrow such sum of money, as it may deem advisable for the purposes aforesaid, provided such loans shall not exceed, in the aggregate, twenty thousand dollars, and it may hypothecate the immovable property of the said orphan asylum as security for the repayment of the said loans and of the interest thereon. Power to borrow money up to a certain sum.

C A P . X C V .

An Act to incorporate "*La Trappe de Notre-Dame du Lac des Deux Montagnes.*"

[Assented to 1st May, 1882.]

WHEREAS the religious trappists of the Lake of Two Mountains, to wit: Fr. M. Guillaume, prior; Fr. M. Jean-Baptiste, priest, cellarer; Fr. M. Alban, priest, and Fr. M. Louis de Gonzague, priest, have, by their petition, represented that they have founded an establishment at the Lake of Two Mountains, in the district of Terrebonne, for the purpose of devoting themselves to agriculture and to teaching it, both in theory and practice; Preamble.

Whereas, already through the generosity of the Seminary of St. Sulpice, of Montreal, they possess, at the Lake of Two Mountains, farms which they are beginning to work, and which they intend to improve, so as to make model farms at which young men may be taught agriculture and stock-raising, and improve themselves in the knowledge thereof;

Whereas, in order to obtain this end more effectually,

they require an act of incorporation which will allow them to possess and act like other civil corporations of the same kind in the country;

Whereas, by their petition, they have applied for an act of incorporation, as aforesaid, and it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Certain persons incorporated.

1. The said Fr. M. Guillaume, Fr. M. Jean-Baptiste, Fr. M. Alban and Fr. M. Louis de Gonzague, and such persons as may, under the constitution and by-laws of their community, unite with or succeed to them, are hereby

Name of the corporation.

constituted a civil corporation, under the name of "*La Trappe de Notre-Dame du Lac des Deux Montagnes*." The

Number of members.

number of the members of such corporation shall never, at any time, be less than four.

Seal of corporation.

2. The corporation may have a common seal and alter, change or renew the same when and as often as they may

Perpetual succession.

deem necessary. It shall have perpetual succession.

Power to sue and be sued.

3. The corporation may sue and be sued before any court of justice in the province, and plead or be impleaded, like all other corporations.

Corporation may acquire property.

4. The corporation may, at any time, purchase, acquire, hold, possess, occupy, have, take, and receive, for itself and its successors, for the use and objects of its incorporation, all lands, tenements, hereditaments, movable and immovable property whatsoever, and may sell, alienate, transfer and make over the same and acquire others in lieu thereof; provided always that the rents, revenue or net receipts from such immovables shall not, at any time,

Limitation.

exceed the sum of twenty five thousand dollars annually.

Power to make by-laws, &c.

5. The majority of the members of the corporation shall have power and authority to make and pass such by-laws, rules and regulations, not contrary to the laws in force in this province, as it may deem useful or necessary for its interests or for its government or for the admission or expulsion of its members, and it may, from time to time, amend, repeal and alter such by-laws or any of such rules and regulations.

Appointment of agents.

6. The majority of the members of the corporation may appoint one or more agents for the transaction of its business.

7. From and after the coming into force of this act, all the property, movable or immovable, the claims, rights and actions belonging to the establishment, at the Lake of Two Mountains, hitherto owned and administered by the petitioners, shall become the property of the corporation of "*La Trappe de Notre-Dame du Lac des Deux Montagnes*," and the corporation hereby constituted shall, at the same time, become liable for all the debts, charges or obligations of the said institution, which shall thereupon cease to exist.

Certain property vested in corporation.

8. It shall be the duty of the corporation to submit, annually, to the lieutenant governor a detailed statement of its immovable property, held under the present act, and of the revenues arising therefrom.

An Act to incorporate "*L'Union St. Joseph de St. Césaire*."

[Assented to 1st May, 1882.]

WHEREAS there exists an association under the name of "*L'Union St. Joseph de St. Césaire*," the object of which is to assist and succour its members in case of sickness and to secure similar assistance and other advantages for the widows and children of deceased members; and whereas the members of the association have, by their petition, prayed that they be incorporated, and it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Preamble.
