

7. From and after the coming into force of this act, all the property, movable or immovable, the claims, rights and actions belonging to the establishment, at the Lake of Two Mountains, hitherto owned and administered by the petitioners, shall become the property of the corporation of "*La Trappe de Notre-Dame du Lac des Deux Montagnes*," and the corporation hereby constituted shall, at the same time, become liable for all the debts, charges or obligations of the said institution, which shall thereupon cease to exist.

8. It shall be the duty of the corporation to submit, annually, to the lieutenant governor a detailed statement of its immovable property, held under the present act, and of the revenues arising therefrom.

An Act to incorporate "*L'Union St. Joseph de St. Césaire*."

[Assented to 1st May, 1882.]

WHEREAS there exists an association under the name of "*L'Union St. Joseph de St. Césaire*," the object of which is to assist and succour its members in case of sickness and to secure similar assistance and other advantages for the widows and children of deceased members; and whereas the members of the association have, by their petition, prayed that they be incorporated, and it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Preamble.

under the name of "*L'Union St. Joseph de St. Césaire*," for the purposes aforesaid, and under such name, may, at any time hereafter, purchase, acquire, possess, hold, exchange, accept and receive, for themselves and their successors, all lands, tenements and hereditaments and real estate and immovables, situate and being in the province of Quebec, necessary for the actual use and occupation of the corporation, not exceeding in annual value the sum of two thousand dollars; and hypothecate, sell, alienate or otherwise dispose of the same and acquire any others in lieu thereof, for the same purposes. And a majority of the members of the corporation, for the time being, shall have full power and authority to make and establish such rules, regulations and by-laws, which shall not be contrary to this act nor to the laws in force in this Province, as they may think proper and necessary for the interest and management of the corporation and for the admission of members, and alter or repeal the same, from time to time, in whole or in part, and also all rules and by-laws which may be in force at the time of the passing of this act. Such majority may do, execute and manage each and every the other matters and things relating to the corporation and the management and administration thereof, within the limits of their powers, regard being nevertheless had to the rules, stipulations, provisions and by-laws prescribed and to be hereafter prescribed; and the principal place of business of this corporation shall be in the Village of St. Césaire.

2. The rents, revenues and profits of the corporation shall be exclusively used and employed in aiding and supporting its members and their widows and orphans; in constructing and repairing the buildings necessary for the purposes of the corporation; and in paying the expenses legitimately incurred for the objects relating to the above purposes.

3. All the real estate and immovables whatsoever belonging to the corporation or which may hereafter be acquired by the members thereof, as such, by purchase, donation or otherwise, and all debts, claims and rights which they may possess, as such, shall be and are hereby vested in the corporation; and the corporation shall assume all the debts and obligations of the association; and the rules, regulations and by-laws, which are now or may hereafter be established for the management of the association, shall be and continue to be the rules, regulations and by-laws of the corporation, until they are altered or repealed in the manner prescribed by this act.

4. The members of the corporation, for the time being, or the majority of them, shall have the power of appointing such agents or other persons to administer the property of the corporation, and such officers, administrators, delegates, employees or servants of the corporation, as may be required for the proper management of its affairs and to allow them a reasonable and suitable remuneration ; and all the officers, so appointed, may exercise such other powers and authority, for the management and administration of the affairs of the corporation, as may be conferred upon them by the rules and by-laws thereof.

5. The present officers of the association shall be those of the corporation, constituted by this act, until others are elected, in accordance with the by-laws of the latter.

6. No sum of money, granted by the corporation under its constitution or any of its by-laws, as aid or assistance to any of its sick members or to the widow or orphans of a deceased member, shall be liable to seizure, either before or after judgment.

7. No person, who is competent to be a witness in any suit or prosecution in which the corporation is a party shall be incompetent as such from the fact that he is a member or an officer of the corporation.

8. The corporation shall be bound to make an annual report to the Lieutenant Governor and to both Houses of the Legislature, containing a general statement of its affairs, which report shall be presented within the first twenty days of each session of the Legislature.

An Act to incorporate "The Septuor Haydn," of Quebec.

[Assented to 1st May, 1882.]

WHEREAS there exists in the city of Quebec an association known by the name of: "The Septuor Haydn," established with the view of promoting the advancement of musical taste and knowledge in this province ; and whereas the members of the said association have, by their petition, prayed that they be incorporated ; and whereas it is expedient to grant their prayer ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:
