

C A P . X X I X .

An Act to amend the Act, 40 Victoria, chapter 21, intitled : “ An Act to amend and consolidate the Game Laws of this Province.”

[Assented to 24th July, 1880.]

WHEREAS it is expedient to amend the Game Laws ^{Preamble.} of this Province ; Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Act of this Province, 40 Victoria, chapter 21, is ^{40 V., c. 21, amended.} amended, by adding after section 6, the following words :
 “ Any person, who shoots at or kills any migratory quail ^{Migratory quail.} in this Province, before the 31st day of December, 1882, shall be liable to a fine of not more than five dollars, or an imprisonment of not more than fifteen days.

C A P . X X X .

An Act to protect toll bridges in this Province.

[Assented 24th July, 1880.]

WHEREAS there are toll bridges in this Province, ^{Preamble.} whose charter does not provide for their protection, in the interest of the proprietor and of the public at large, and it is important to provide therefor ; Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Every person, firm or company, being proprietor of any bridge, may cause to be posted on any such bridge, a ^{Forbidden to go faster than at a walk.} written or printed notice, in French and English, prohibiting any person from driving any vehicle faster than at a walk on such bridge.

2. Whosoever, after such notice shall have been so ^{Fine for contra-vention and for cutting, &c., bridge.} posted, drives any vehicle, faster than a walk on any such bridge, or cuts, defaces or injures any part of such bridge, or the posts or any other object forming part thereof or depending therefrom, incurs a fine, in the nature of damages, of not less than two nor more than twenty dollars, in addition to the damages caused.

3. Any suit for the contravention of this act may be ^{Before whom suits to be brought.} brought, by the proprietor of any such bridge, before the

magistrate's court or the circuit court of the county or district, in the limits of which such contravention has taken place, or before any justice of the peace, residing in the municipality, if there be one, if not, before any justice of the peace, residing in a neighboring municipality, in the district.

Act in force. **4.** This act shall come into force on the day of its sanction.

C A P. X X X I.

An Act to amend the Act of this Province, 42-43 Victoria, chapter 46, intituled : " An Act to amend the Act to adjust the boundary lines and settle the titles in certain ranges of the township of Grenville.

[Assented to 24th July, 1880.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

S. 4, 42-43 V.
c. 46, amended

1. Section 4 of the act of this province, 42-43 Victoria, chapter 46, is amended by striking out, in the ninth line thereof, the figure : " 7," and replacing it by the figure : " 8," and by further, striking out, in the ninth and tenth lines of the said section, the words : " one hundred and three and one half," and substituting therefor the words : " ninety-eight."

Act in force. **2.** This act shall come into force on the day of the sanction thereof.

C A P. X X X I I.

An Act to amend the Act of this Province, 39 Victoria, Chapter 33, intituled : " An Act to amend and consolidate the various acts respecting the Notarial Profession in this Province."

[Assented to 24th July, 1880.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 21 of the act 39 Victoria, chapter 33, is amended, by adding thereto the following paragraph :

" No person, other than a practising notary public, can demand any fees for drawing up and preparing writings
