

3. The corporation may make such by-laws, not contrary to law or the provisions of this act, as they shall deem expedient for the administration and government of the corporation, and may repeal or annul the same, from time to time, observing always, however, such formalities as by such by-laws may be lawfully prescribed to that end, and generally shall have all the corporate powers necessary to the ends of this act.

4. The by-laws, constitution and regulations of the said society, not being contrary to law or to the provisions of this act, shall be the by-laws of the corporation hereby constituted, until they shall be repealed or altered, as aforesaid ; and, until others shall be elected, according to the by-laws of the corporation, the present officers of the society shall be those of the corporation ; and the said corporation is hereby vested with all the assets and rights, and made responsible for all obligations and liabilities of the said society.

5. All subscriptions, heretofore made to the said society, shall be payable to the said corporation, and are hereby declared to be as binding upon the subscribers as if this act had been previously passed.

#### C A P. L X V .

An Act to change the name of "Le Collège de Monnoir," to that of "Le Petit Séminaire de Ste. Marie de Monnoir," and for other purposes.

[Assented to 24th Ju'y, 1880.]

WHEREAS the Reverend Edouard Crevier, Vicar-General of the parish of Ste. Marie de Monnoir, in the district of St. Hyacinthe, F. X. Jeannotte, Parish Priest, and others, of the same place, have, by their petition, represented that, in virtue of the Act 18 Victoria, chapter 73, there exists, in the said parish of Ste. Marie de Monnoir, a college for the education of youth, incorporated under the name : of "Collège de Monnoir ;" that since several years the said college has been erected into a "petit séminaire" by the Roman Catholic Bishop of St. Hyacinthe, and for this reason it has become necessary to make certain amendments to the act of incorporation of the said : "Collège de Monnoir ;" Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** The Corporation heretofore known under the name of the *Collège de Monnoir*, shall hereafter be known by the name of : *La Corporation du Petit Séminaire de Ste. Marie de Monnoir*, and shall be composed of the Superior, Assistant-Superior, Director, Prefect of Studies, Bursar of the said institution and of their successors in office and of all others whom the council of management shall deem necessary to have as members of the said corporation, and under, such name, shall have perpetual succession and shall enjoy the rights and privileges conferred on it by the act 18 Victoria, chapter 73, and may from time to time, alter, renew or change its common seal at its pleasure ; and shall by the same name, be able to purchase, acquire, hold, possess and enjoy, have, take and receive, to and for the purposes of the said corporation, any moveable or immoveable property situate and being in this Province ; provided that the annual value thereof does not exceed six thousand dollars, over and above of the buildings necessary for the said college and the ground on which they are or may be erected, and the same sell, alienate and dispose of, and purchase others in their stead for the same purpose ; and under the same name shall and may be able and capable in law to sue and be sued as any other body politic or corporate ; And any majority of the members of the corporation, for the time being, shall have power and authority to make and establish such by-laws, rules, orders, and regulations, not being contrary to this act, or to the laws in force in the province, as shall be deemed useful and necessary for the interests of the said corporation, and for the management thereof, and for the admission of members into the said corporation ; and, from time to time, may alter, repeal and change the said by-laws, rules, orders and regulations, or any of them, and shall and may do, execute and perform all and singular the other matters and things relating to the said corporation and the management thereof, or which shall or may appertain thereto, subject nevertheless to the rules, regulations, restrictions and provisions, hereinafter prescribed and established. And the persons, mentioned in this section, shall appoint a council of management which shall be composed of the members of the said corporation, in accordance with the rules and regulations of the institution.

**2.** Provided always that the rents, revenues, issues and profits of all property, real or personal, held by the said corporation, shall be exclusively employed for the advancement of education, for the education of youth, and for objects legitimately connected with or depending on the purposes aforesaid.

3. All the moveable and immoveable property which now belongs to the : " Collège de Monnoir " are hereby declared to belong to the corporation of " *Le Petit Séminaire de Ste. Marie de Monnoir.*" Declaration as to property of Collège de Monnoir.

4. The Bishop of St. Hyacinthe shall, when present, have the right to vote at the proceedings of the said Council of the corporation of " *Le Petit Séminaire de Ste. Marie de Monnoir,*" at which he may preside. Right of Bishop of St. Hyacinthe to vote.

5. It shall be the duty of such corporation, to submit to the Lieutenant Governor of this province, at the end of each year, a detailed statement of the number of members of such corporation, the number of teachers employed in the different branches of instruction, the number of pupils following the course of studies therein taught, and of the moveable and immoveable properties held in virtue of the present act, and the revenues arising therefrom. Statement to be submitted to lieut. gov.

6. The bursar shall keep the register, and be responsible therefor. Register to be kept.

The council of the corporation of " *Le Petit Séminaire de Ste. Marie de Monnoir,*" shall have the right to keep minutes of its proceedings, a duly certified copy of which shall be *prima facie* evidence before any court of justice in this Province. Minutes. Copy thereof.

7. The members, composing such corporation, shall have the right to determine the number of persons who shall compose the council and the quorum thereof. Council and quorum.

8. The place of business of the said corporation shall be at the village of Marieville, in the parish of Ste. Marie de Monnoir, in the district of St. Hyacinthe. Place of business.

9. All the provisions of the act, 18 Vict., chap. 73, which are inconsistent with this act, are repealed. Inconsistent provisions of 18 V., c. 73, repealed.

10. This act shall come into force on the day of its sanction. Act in force.

#### CAP. LXVI.

An Act to amend the statute of the Province of Canada, 28 Vict., chapter 53, intituled : " An Act to incorporate the Presbyterian College of Montreal."
