

## CAP. LXXI.

An Act to incorporate "*La Société St. Jean-Baptiste de la ville Salaberry de Valleyfield.*"

[Assented to 24th July, 1880]

Preamble.

**W**HEREAS an association, known by the name of "*La Société St. Jean-Baptiste de la ville Salaberry de Valleyfield,*" exists since a few months in the Town of Salaberry de Valleyfield, in the district of Beauharnois, for the purpose of aiding and assisting the members thereof in case of illness, and of affording a similar assistance and other advantages to the widows and children of deceased members; whereas, the members of the said association have, by their petition, prayed to be incorporated; and whereas, it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts, as follows:

Persons incorporated.

1. Jules Guernon Lussier, Solyme Augustin Brodeur, Damase Pitre, Joseph Cardinal, Isaïe Laberge, Benjamin Viau, Joseph Monette, Arthur Lesage, Arthur Sauvé, and all other persons who are now, or may hereafter become members of the said association under the provisions of the present act, shall be and they are hereby constituted a body politic and corporate, under the name of: "*La Société Saint Jean-Baptiste de la ville Salaberry de Valleyfield,*" and under such name may, at all times hereafter, buy, acquire, hold, possess, exchange, accept and receive, for themselves and their successors, all lands, tenements, hereditaments, real and immoveable property, situated and being in the Province of Quebec, necessary for the actual use and occupation of the said corporation; and may sell, alienate, hypothecate and otherwise dispose of the same, and acquire other property instead thereof, for the same purposes; but the annual value of such property shall not, at any time, exceed the sum of two thousand dollars; and a majority whatever of the members of the said corporation, shall have full power and authority to enact all by-laws and regulations, not inconsistent with this act and with the laws then in force in the Province of Quebec, as may be deemed expedient and necessary for the interest and administration of the affairs of the said corporation, and the admission of members thereto, and may amend, modify and repeal the same, from time to time, in whole or in part, as well as those existing at the time of the passing of this act; and may also execute and administer, and cause to be executed and administered all and every other affair

and thing, concerning the said corporation and the government and administration thereof, within its capacity, taking into consideration, nevertheless, the stipulations, provisions and by-laws prescribed and to be established hereafter.

2 The rents, revenues and profits of the said corporation shall be appropriated and employed exclusively to and for the assistance of the members thereof; to the construction and repairs of the buildings required for the purposes of the corporation, and to the payment of expenses lawfully incurred in carrying out any of the objects relating to the aforesaid purposes; provided also, that no sum of money, granted by the said corporation, under its constitution or under any of its by-laws, by way of aid or assistance to any of its members when ill, or to the widow and orphans of a deceased member, shall be liable to seizure under any writ, issued from any court in this province, either before or after judgment; provided, always, that nothing in this section shall prejudice in any manner whatsoever, the rights of any creditor to any sum of money due by the corporation to any of its members, under any contract or undertaking entered into between the said corporation and such member.

3. All the real and personal property whatever, belonging to the said association or which shall hereafter be acquired by the members thereof, in such quality, through purchase, donation or otherwise, and all debts, claims and rights, which they may have in their said quality, shall be and are by these presents vested in the corporation constituted by this act; and the said corporation shall be charged with the liabilities and obligations of the said association; and the rules, by-laws and regulations now existing, or which shall hereafter be established for the government of the said association, shall be and continue to be the rules and by-laws of the said corporation, until amended, modified or repealed in the manner prescribed by this act.

4. The members of the said corporation or a majority of them, shall have power to appoint such officers, administrators, delegates and servants as may be required for the due management of its affairs, and to allow them respectively a reasonable and suitable remuneration; and all the officers so appointed, may exercise such other powers and authority for the due management and administration of the affairs of the corporation as may be conferred upon them by the rules and regulations of the said corporation.

5. The office and place of business of the said corporation shall be in the said town of Salaberry de Valleyfield, and the regular meetings shall take place in the said town.

Annual report to Legislature.

6. The said corporation shall be obliged to make an annual report to both branches of the Legislature, giving a general statement of its affairs; which said report shall be presented within the first twenty days of each session of the Provincial Legislature.

Deprivation of charter in certain events.

7. Should the said corporation take part in any strike or in any way whatever or encourage the same it shall forfeit all its rights under the present act.

## C A P . L X X I I .

An Act to incorporate "*La Société St. Jean-Baptiste de Lachine.*"

[Assented to 24th July, 1880.]

Preamble.

WHEREAS an association, known by the name of: "*La Société St. Jean-Baptiste de Lachine,*" has been organized and now exists in the town of Lachine, with the object of assisting its sick or infirm members, and of paying certain indemnities to the widows and children of its deceased members; and, whereas Clément Deschamps, Jean-Baptiste Thessereau, Placide Robert, Jean-Baptiste Poitras, Pierre Gauthier, Napoléon Duquette, Michel Clagne, Dosithée Jolie, Hormisdas Deslauriers and Léon Forest, all of the town of Lachine, and members of the said association, have prayed, by their petition, that the said society be incorporated; and, whereas it is expedient to grant their prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Persons incorporated.

1. Clément Deschamps, Jean-Baptiste Thessereau, Placide Robert, Jean-Baptiste Poitras, Pierre Gauthier, Napoléon Duquette, Michel Clagne, Dosithée Jolie, Hormisdas Deslauriers, Léon Forest, and such other persons as are now members of the said association, or may herebecome members thereof, shall be, and are by the present act, constituted a body politic and corporate, under the name of: "*La Société St. Jean-Baptiste de Lachine,*" and, under such name, may exercise all and each of the general powers with which bodies politic are vested, subject always to the provisions of the present act, and may, in virtue of any lawful title, have and possess all movable
