

And whereas the said petitioner desires to be admitted as a member of the Bar of this province, and has prayed, by his petition, that he may, upon due examination, be admitted to practise, in this province, as an attorney and advocate, without being required to devote the usual time to the study of such profession prescribed for a student at law; and whereas the Council of the section of the district of Montreal have, by resolution, declared that under the circumstances it does not object to his application;

And whereas, it is expedient to grant the prayer of the said petition; therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. It shall be lawful for the Bar of the Province of Quebec, section of the district of Montreal, at any time after the passing of this act, to admit the said Louis H. Pignolet as an attorney and advocate, after having passed his examination; provided that the examiners of the said section be authorized to proceed to his examination by a resolution to that effect, passed at any general or special meeting of the council of that section of the Bar, held at least ten days after notice of the intention to move the adoption of such resolution has been given.

2. On delivery of the diploma to the said Louis H. Pignolet, he shall be required to take the oath of allegiance.

Oath of allegiance required.

The secretary of the Bar of the Province of Quebec, section of the district of Montreal, is authorized to administer such oath and he shall endorse on the diploma a certificate of such oath having been taken.

#### C A P. C.

An Act to authorize the Bar of the Province of Quebec, to admit George Arthur Hughes, as an Attorney and Advocate.

[Assented to 24th July, 1880.]

**W**HEREAS George Arthur Hughes, of the city of Montreal, hath by petition represented that he has studied Law for several years in this Province, and has, after examination, been admitted to practise as a notary, in the said Province of Quebec and that he has practised as such; and whereas he desires to be admitted to practise as an advocate in the said province of Quebec; and whereas he hath prayed that an act of the Legislature should pass

for that purpose; and whereas it is expedient to grant the prayer of the said petition; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. It shall be lawful for the Bar of the Province of Quebec, section of Montreal, at any time after the passing of this act, to admit the said George Arthur Hughes, as an attorney and advocate, and to practise law as such, as soon as he has passed the usual examination, after notice of one month of his intention to be examined, any law, usage or regulation to the contrary notwithstanding.

### C A P. C I.

An Act to authorize the Bar of the Province of Quebec, to admit Hormisdas Jeannotte, dit Lachapelle, as one of its members.

[Assented to 24th July, 1880.]

Preamble.

**W**HEREAS Hormisdas Jeannotte, dit Lachapelle, of the city of Montreal, has, by petition, represented that he has studied law since the fifteenth of February, one thousand eight hundred and sixty-seven; that he has obtained from the Victoria University of Cobourg, Ontario, the degree of Bachelor at Law, and that he was admitted, after examination, to the practice of the profession of notary, and that he has practised, as such, in the city of Montreal, since the month of June, one thousand eight hundred and seventy; whereas he desires to be admitted to practise the profession of advocate; and whereas he has prayed that an Act of this Legislature be passed and granted to him for that purpose; and, whereas it is expedient to grant such prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

The Bar of the Province of Quebec, section of the dis- of Montreal, at any time after the passing of this act, may, after examination, admit the said Hormisdas Jeannotte, dit Lachapelle, as attorney and advocate, and to practise law as such, as soon as he shall have passed the usual examination, after previously giving one month's notice of his intention to submit himself to such examination, any law, custom or by-law to the contrary notwithstanding.
