

## CAP. CIII.

An act to authorize the Bar of the Province of Quebec, to admit Roch Pamphile Vallée amongst its members.

[Assented to 24th July, 1880.]

Preamble.

**W**HEREAS Roch Pamphile Vallée, of the city of Quebec, has followed a course of Roman Law, of Civil Law, of Administrative Law, of Commercial Law and of Procedure at Laval University, and was admitted to practice the profession of notary by the Provincial Board of Notaries, in October, one thousand eight hundred and seventy-two;

Whereas, during the years one thousand eight hundred and seventy-three, one thousand eight hundred and seventy-four and one thousand eight hundred and seventy-five, he studied law with Elzéar Déry, of the city of Quebec, Esquire, advocate, and since that period he has not discontinued his legal studies ;

Whereas he has been unable to obtain admission to the practice of the profession of advocate, because he had neglected to obtain an indenture (*brevet*), admitting him to the study of law ; but whereas he did, on the thirteenth day of January, one thousand eight hundred and eighty, comply with this provision of the law, as established by the certificates by him filed ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**I.** It shall be lawful for the Bar of the Province of Quebec, section of the district of Quebec, or any other section, at any time, to admit, after examination, the said Roch Pamphile Vallée to practice the profession of attorney and advocate.

## CAP. CIV.

An Act to declare and confirm the name of Louis Philippe Pelletier, of the city of Quebec, Esquire, advocate.

[Assented to 24th July, 1880.]

Preamble.

**W**HEREAS Louis Philippe Pelletier, of the city of Quebec, Esquire, advocate, has, by his petition, represented that, for a great number of years, he has been known under the name of "Louis Philippe Pelletier," and that his name has been so entered in a great number of deeds, and other authentic and private writings, notwith-

standing that, in his act of birth, his christian names are as follows: "Louis Thomas Godfroi"; and whereas certain inconvenience may result to the said Louis Philippe Pelletier, from the fact that the said Christian names are not the same in certain public or other deeds; and whereas, in order to remedy such inconveniences, the said Louis Philippe Pelletier has, by his said petition, prayed for the passing of an act, and whereas it is expedient to grant his prayer: Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. The name of the said Louis Philippe Pelletier is hereby confirmed, and declared to have been and to be, as so written, his true name, and under such name he may sue and be sued, claim, exercise and possess all advantages, benefits, rights, privileges and titles, inheritances, legacies and gifts, which may have been or may be given him, or may have belonged or shall belong to him, even if his said Christian names have not been written in the same manner; and all deeds, purchases, agreements, writings and documents, made or passed by him, or in his favor, under such name, shall bind him, and shall bind others towards him; and the said Christian names are declared to be his true Christian names to all intents and purposes whatsoever.

### C A P. C V.

An Act to declare and confirm the name of Joseph Eloi de Gagné, of the parish of Les Eboulements, Esquire, Merchant, and for the relief of his descendants.

[Assented to 24th July, 1880.]

**W**HEREAS Joseph Eloi de Gagné, of the parish of Les Eboulements, county of Charlevoix, esquire, merchant, has, by his petition, represented that, for a great number of years, he has been known under the name of Joseph Eloi de Gagné, and that his name has been so entered in a great number of registers and other public documents, and in a great number of deeds, and other authentic, and private writings, and that his said family name has been so transmitted to his children, notwithstanding that in his act of birth the name of his father is spelt: *Desgagner*, and his christian names are spelt: *Joseph Eloy*; and whereas certain inconvenience may result to the said Joseph Eloi de Gagné, or to his descendants, from the fact that the said
