An Act to amend "The act incorporating the Trustees of the American Presbyterian Society of Montreal."

[ *Assented to 9th March, 1878* ]

**W**HEREAS "The Trustees of the American Presbyte- <sup>Preamble.</sup> rian Society of Montreal," a body corporate and politic, incorporated under a statute of the Province of Canada passed in the session, held in the 27th and 28th years of Her Majesty's reign, have, by their petition prayed for certain amendments to the said act of incorporation, and it is expedient to grant such prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** The said corporation shall have power to acquire <sup>Right to</sup> by purchase, donation, exchange, legacy or other title, and <sup>hold property</sup> to hold, possess and enjoy subject to the registration set forth in the twenty-third section of the said amended act, any moveable or immoveable property necessary for the erection and maintenance of mission churches and mission <sup>Purpose.</sup> schools already established, or to be established hereafter, in connexion with the said congregation or religious society, and to supervise, administer and manage the same, with power to make by laws, rules or regulations <sup>By-laws.</sup> in respect to such property, management, supervision and administration as may be necessary, to be approved and ratified, in manner and form as in the said amended act is set forth; and the said corporation may from time to <sup>Alienation of</sup> time alienate or hypothecate the said property, applying <sup>property.</sup> the proceeds towards establishing or supporting other mission churches and mission schools, or for religious purposes in connexion with the said congregation or religious society.

**2.** The said corporation shall at all times, when thereto <sup>Report to</sup> required by the Legislature of the Province of Quebec make <sup>Legislature.</sup>

a full return of the immoveable property acquired under this act, and of the receipts and expenditure in respect thereof, with such details and other information as may be required by the said Legislature.

## C A P . X L I .

An Act to amend the Act 32 Vict., cap. 89, intituled :  
 “ An Act to incorporate the Protestant Institution  
 for Deaf Mutes and for the Blind.”

[Assented to 9th March, 1878.]

Preamble.

**W**HEREAS the board of Governors of the Protestant Institution for Deaf Mutes and for the Blind have, by their petition, set forth that Joseph Mackay, Esquire, has acquired certain real estate and erected suitable buildings thereon which he is now prepared to place at the disposal of the said Institution, by way of donation, to be used for the purposes for which the same was created, and that it has become advisable, in view of the said proposed donation, to change the name of the said Institution to “The Mackay Institution for Protestant Deaf Mutes,” and have prayed that the said act be amended as the same is hereafter amended ; and whereas it is expedient to grant the prayer of their said petition ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

New name.

**1.** The corporate name of the said Institution shall be changed from “The Protestant Institution for Deaf Mutes and for the Blind,” to that of “The Mackay Institution for Protestant Deaf Mutes ;” but the said corporation shall not therefore be deemed a new corporation and all real and moveable property, debts, rights, claims, privileges and powers, heretofore vested in or contracted by the said Protestant Institution for Deaf Mutes and for the Blind, are hereby transferred to “The Mackay Institution for Protestant Deaf Mutes,” which by its corporate name is hereby substituted, to all intents and purposes, for the said Protestant Institution for Deaf Mutes and the Blind.

**2.** Section one of the said act is hereby amended, by adding thereto the words : “in addition to the value of the property occupied for the purposes of the said Institution.”
