DAY OF JANUARY, ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FOUR.

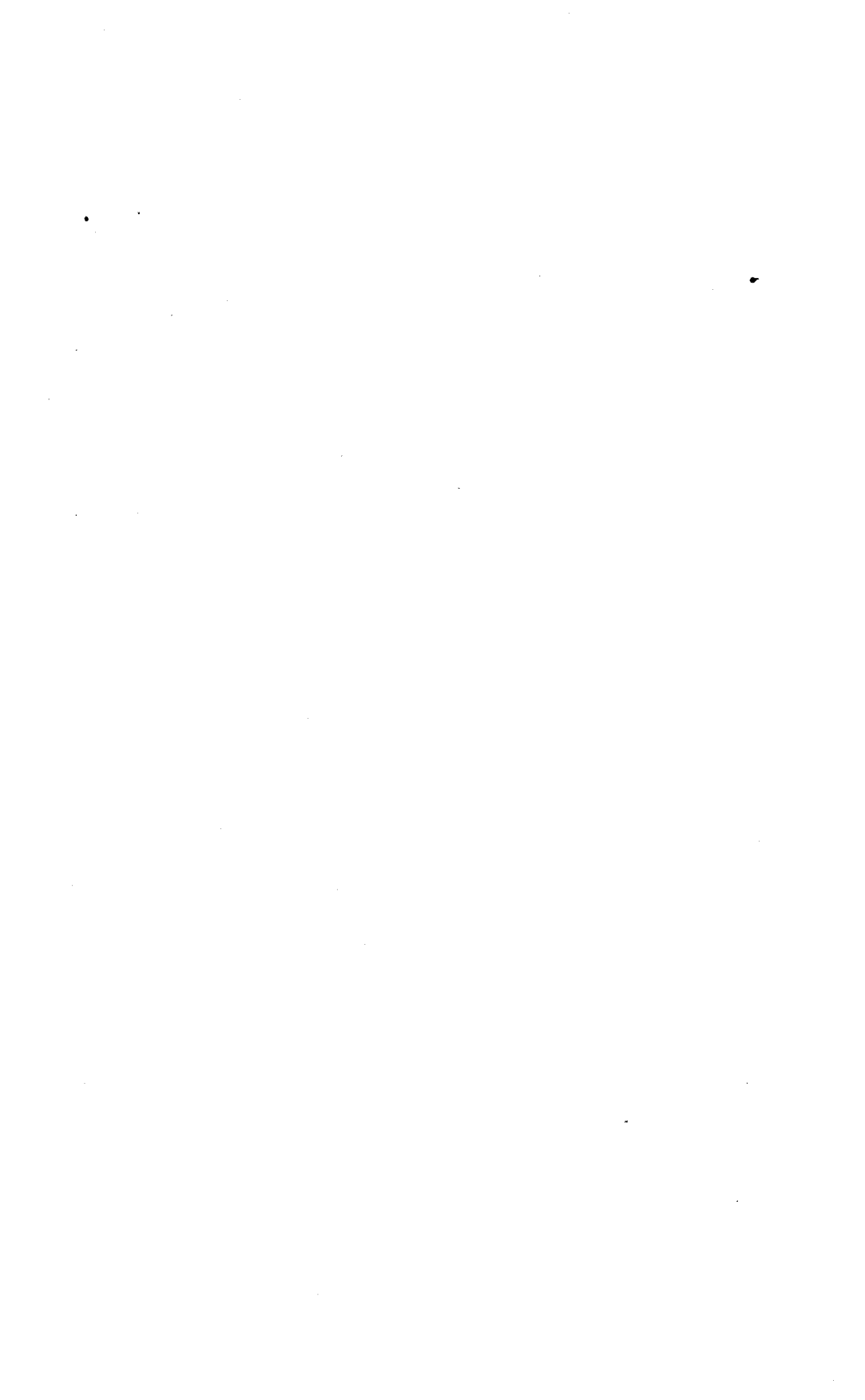
