

Beauharnois and the township of Godmanchester and the parish of St. Anicet, for the purposes of a road," are no longer suitable and advantageous, and prevent the said petitioners from laying out such a road as they require ; and whereas, the said petitioners pray that the said act be amended, and it is expedient to grant their petition ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

I. The act twentieth Victoria, chapter one hundred and nineteen is amended by substituting, instead of the first section, the following :

" The municipalities of the counties of Huntingdon, Beauharnois and Chateauguay which are interested in the construction of the road between the seigniory of Beauharnois, the township of Godmanchester and the parish of St. Anicet, shall have power to cause the boundary line between the seigniory of Beauharnois and the township of Godmanchester and the parish of St. Anicet, to be drawn and marked out by such person or persons, in such direction and in such manner as they shall deem most proper."

C A P . X L I .

An Act to amend the Act to divide the County of Rimouski into two registration divisions.

[Assented to 1st February, 1870.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Sec. 1 of 32 V.,
c. 45 amended.

I. The first section of the act of this province, thirty-second Victoria, chapter forty-five, is hereby amended, by substituting to the words "Rivière Métis," in the said section, the words "division line between the seigniory of Métis and the fief Pachot, and thence by the line dividing the seigniory of Lepage and Thibierge from the township of Cabot, the said line being afterwards prolonged in a direct line as far as the depth of the county of Rimouski."

C A P . X L I I .

An Act to annex a portion of the township of Tingwick to the township of Wotton.

[Assented to 1st February, 1870.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. From and after the passing of this act, the south-eastern halves (the lots being divided crosswise parallel with the concession lines,) of lots numbers twenty-nine, twenty-eight, twenty-seven, twenty-six and twenty-five in the eleventh range of the township of Tingwick, in the county of Arthabaska, shall be annexed to the township of Wotton, in the county of Wolfe, for municipal, judicial and school purposes.

Half of certain lots in Tingwick annexed to Wotton.

2. Nevertheless, the proprietors of the parts of lots thus annexed, and their representatives, shall be held and liable, as regards the past only, for all municipal, school or other debts or dues whatsoever, contracted and payable when this act comes into force, by the township of Tingwick, and for such portions thereof as they would have been liable for, had they continued to form part of the said township of Tingwick.

How former debts of Tingwick shall be borne.

C A P. XLIII.

An Act to divide the municipality of the Township of Cape des Rosiers, in the County of Gaspé, into two separate municipalities.

[Assented to 1st February, 1870.]

WHEREAS the local council of the municipality of the township of Cape des Rosiers, in the county and district of Gaspé has, by petition, prayed for the passing of an act to separate the present municipality of the township of Cape des Rosiers, and to erect it into two separate municipalities; and whereas it is expedient that its prayer be granted; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Preamble.

1. From and after the passing of this act, the municipality of the township of Cape des Rosiers, shall be separated for municipal purposes, and shall form two separate municipalities, under the name of the "Corporation of the Municipality of Cape des Rosiers" and the "Corporation of the Municipality of Griffin Cove."

Township of Cape des Rosiers divided into two municipalities.

The municipality of Cape des Rosiers shall comprise the first and second ranges south, and the first and second ranges east, of the late municipality of the township of Cape des Rosiers; the inhabitants residing in those parts of the late municipality of the township of Cape des Rosiers so bounded, shall constitute a body politic and corporate, under the name of the "Corporation of the Municipality of Cape des Rosiers," for all municipal purposes whatsoever.

Limits of the Municipality of Cape des Rosiers.

Limits of the Municipality of Griffin Cove.

2. The municipality of Griffin Cove shall comprise the third range south, the first and second ranges north of the late municipality of the Township of Cape des Rosiers, and the first range south, and the first range north of Griffin Cove, also of the late municipality of the said township of Cape des Rosiers; the inhabitants residing in that part of the late municipality of the township of Cape des Rosiers so bounded, shall constitute a body politic and corporate, under the name of the "Corporation of the Municipality of Griffin Cove," for all municipal purposes whatsoever.

Municipal Council of Cape des Rosiers.

3. The municipal council of Cape des Rosiers shall remain constituted as at present, with the exception of such of the councillors as may be resident in the new municipality of Griffin Cove, and shall comply with the provisions of the Lower Canada consolidated municipal act and its amendments as regards the appointment of successors to the said councillors retiring.

Election of Councillors for Griffin Cove.

4. In the course of the first three months after the passing of the present act, a meeting of the inhabitants of the municipality of Griffin Cove shall be called by three or more electors of the said municipality, and the electors present at such meeting shall choose one of their number to preside over such meeting, and shall select from among themselves seven councillors to form the municipal council of Griffin Cove; and the said election whether unanimous or contested, shall be proceeded with, in all respects, in conformity with the provisions of the Lower Canada consolidated municipal act and its amendments, as if it had taken place on the second Monday of January.

Councillors if not elected, to be named by Lieut.-Governor.

5. If, in the course of the first three months after the passing of this act, the election of the councillors has not taken place as hereinbefore stated, then the councillors shall be appointed by the lieutenant-governor, as provided by law.

Effect of existing by-laws, &c., as regards Griffin Cove.

6. The valuation roll, *procès-verbaux*, repartitions, by-laws and all other documents of record in the archives of the present municipality of the township of Cape des Rosiers and affecting or referring to the new municipality of Griffin Cove, shall continue to affect or refer to the said municipality of Griffin Cove, until amended or renewed by the municipal council thereof according to law; and copies duly authenticated of the valuation roll, *procès-verbaux* or other documents, referring to the said new municipality of Griffin Cove shall have the same effect as if they had been made by the new municipal council of Griffin Cove, and shall form part of the archives of the said new municipal council, until amended or renewed as aforesaid.

Division of debts and assets, between

7. The moneys in the hands of the secretary-treasurer and the liabilities of the municipality of the township of

Cape des Rosiers, on the day of the passing of this act, shall be divided between the corporation of the municipality of Cape des Rosiers and the corporation of the municipality of Griffin Cove, in proportion to the amount of property valued on the last valuation roll, in the township of Cape des Rosiers. the two municipalities.

8. The councillors of the township of Griffin Cove, being elected, or appointed by the lieutenant-governor, as hereinbefore provided, shall meet at the place, on the day, and at the hour determined upon for holding the first session of the council, to appoint a mayor, and then shall conform to the Lower Canada consolidated municipal act and its amendments as regards the appointment of other officers, and for all other purposes generally whatsoever. C A P . X L I V .

An Act to change the limits of the Counties of Joliette and Montcalm.

[Assented to 1st February, 1870.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The territory comprising the lots of land numbers one, two and three of the first range of the township of Kildare, in the county of Joliette, is annexed to and forms part of the parish of St. Alphonse de Liguori and of the county of Montcalm, for all civil and political purposes whatsoever. Part of Kildare annexed to St. Alphonse de Liguori.

2. The first section of chapter two of the consolidated statutes of Canada, and the sixteenth and seventeenth subsections of section one, of chapter seventy-five of the consolidated statutes for Lower Canada, shall be read and interpreted, in so far as they apply to this province, in conformity with the foregoing provisions. Sec. 1, of C. S. C. and §§ 16 and 17 of sec. 1, of C. S. L. C. amended.

C A P . X L V .

An Act to amend the Act of the Legislature of this Province, thirty-second Victoria, chapter sixty-nine, relating to the Dental Association in this Province.

[Assented to 1st February, 1870.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section fourteen of the act of the legislature of this province thirty-second Victoria, chapter sixty-nine, is Sec. 14, 32 V., c. 69, repealed.
