### X L I I I .

An Act to amend chapter 71 of the Consolidated Statutes of Canada.

[Assented to 5th April, 1869.]

**H**ER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Sec. 1 of C. S.  
C. e. 71 amended.

1. The first clause of the seventy first chapter of the Consolidated Statutes of Canada shall be amended by adding thereto the following :

1. Any number of persons in the province of Quebec, may unite themselves into a society for making provision, by means of contributions and donations, from the members of the society or from the public, or by other means, for the rescue and reformation of fallen women.

### X L I V .

An Act to divide the municipality of the county of Rimouski into two separate municipalities.

[Assented to 5th April, 1869.]

Preamble.

**W**HEREAS the very large extent of the county of Rimouski, presents grave difficulties and serious obstacles to the mayors and other persons who are interested in, being present at the sittings of the county council, whereof some, to reach the *chef-lieu* at Rimouski, where the said sittings of the said county council are held, have to traverse a distance of one hundred miles and upwards; and whereas it is expedient to divide the said county municipality into two separate municipalities: Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. On, and after the first day of the month of July next, after the passing of this act, the county of Rimouski shall be, for municipal purposes, divided into two separate county municipalities.

Limits of the  
first division.

2. The first of such divisions shall constitute a corporation, under the name of "the corporation of the first division of the county of Rimouski," and shall include all

the parishes and townships, from the western extremity of the said county, to the line dividing the seigniory of Metis, from the township of MacNider.

3. The second of the said divisions shall constitute a corporation under the name of "the corporation of the second division of the county of Rimouski," and shall include all the parishes, municipalities and townships from the said division line, unto the eastern extremity of the county of Rimouski. Limits of the second.

4. All the provisions of the law respecting municipalities shall apply to each of the said divisions, as if each of the same were a county, and each of the said divisions shall be, and shall be deemed to be, a county municipality. Each to be a county municipality.

5. The county council of the first division shall hold its sittings in the village of Rimouski and that of the second division shall hold its sittings in the parish of St. Jerome de Matane. Place of meetings of councils.

## X L V .

An Act to divide the county of Rimouski into two registration divisions.

[Assented to 5th April, 1869.]

**W**HEREAS, the very large extent of the county of Rimouski, gives rise to great difficulties with respect to the registration of titles, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows: Preamble.

1. On and after the day to be fixed by proclamation as hereinafter mentioned, the county of Rimouski, for all the purposes of the acts relative to the registration of titles and other documents affecting real estate in the province of Quebec, shall be divided into two registration divisions, whereof one, which shall be called the first registration district of the county of Rimouski, shall include all the parishes and townships, from the eastern boundary of the county of Rimouski up to the river Métis, and the other, to be called the second registration district of the county of Rimouski, shall include the remainder of the said county. County of Rimouski to form 2 registration divisions. Limits of the first. Limits of the second.

2. The registry office of the said first registration district shall be held in the parish of St. Jérôme de Matane. Place of registry office of first

The present registrar shall, without any new appointment, be the registrar for the said second registration district, and the registry office at present established at St. Germain de Rimouski shall be and continue to be the registry office of the said second district. Present registrar to continue in second division.
