CAP. I.

An act for granting to Her Majesty certain sums of money required for defraying certain Expenses of the Civil Government for the eighteen months ending on the thirty-first of December, one thousand eight hundred and sixty-eight, and for other purposes connected with the Public Service.

[Assented to 24th February, 1868.]

MOST GRACIOUS SOVEREIGN :

WHEREAS it appears by messages from His Excellency, the Honorable Sir Narcisse Fortunat BELLEAU, Knight, Lieutenant Governor of this Province of Quebec, and the estimates accompanying the same, that the sums hereinafter mentioned are or may be required to defray certain expenses of the Government of this Province, not otherwise provided for, for the eighteen months ending on the thirty-first day of December, one thousand eight hundred and sixty-eight, and for other purposes connected with the public service ; may it therefore please Your Majesty, that it may be enacted, and be it enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislature of Quebec, that :

1. From and out of the consolidated revenue fund of this province, there shall and may be paid and applied, a sum not exceeding in the whole two million, ninety seven thousand, seven hundred and seventeen dollars and fifteen cents, for

defraying the several charges and expenses of the civil government and public service of this province, or which, in the interest of the public service, may require to be so paid and applied, whether for account of this province or otherwise, for the eighteen months ending on the thirty-first day of December, one thousand eight hundred and sixty-eight, which are set forth in the schedule to this act, and for the other purposes therein mentioned.

Payments not to be deemed debts of the province, but to be subject to future settlement of accounts with the Dominion and Ontario.

2. Nothing herein or in the said schedule contained, nor yet any payment or application whatever of moneys hereby appropriated, or of any part thereof, shall be held to import that such moneys are so paid or applied for charges or expenses of this province properly so called, or are not otherwise provided for, or are to be finally carried to account of the said consolidated revenue fund; but on the contrary, every such payment and application shall be held to be only made provisionally from such fund, and subject to all rightful adjustment in account hereafter, in respect of the dominion and of the province of Ontario, and of all special funds which the same may at all affect, and otherwise.

Accounts to be rendered to legislature.

3. Accounts in detail of all moneys expended under the authority of this act, shall be laid before both houses of the legislature of this province at the then next session thereof.

Account to her majesty.

4. The due application of all moneys expended under the authority of this act, shall be accounted for to her majesty, her heirs and successors, through the lords commissioners of her majesty's treasury, in such manner and form as her majesty, her heirs and successors, shall be pleased to direct.
