C A P. X X V I.

An Act to amend certain articles of the Civil Code and to add further provisions to the said code.

[Assented to 21st March, 1889.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 2137 of the civil code, as contained in article 5835 of the Revised Statutes of the Province of Quebec, is amended by replacing the second paragraph thereof by the following :

Memorial.

“ The memorial may also be made according to article 2144a. ”

2. Article 2144a, as contained in article 5837 of the said Revised Statutes, is replaced by the following :

How memo-
rial to be made
and attested.

“ 2144a. The memorial may also be executed before a notary by deed *en minute* or *en brevet*.

“ The memorial so executed need not be attested before a witness nor proved under oath nor be accompanied by the title of which it is a memorial, notwithstanding the provisions of articles 2137 and 2140 of this code, and may contain the official number even if such number be not in the title of which it is a memorial.”

3. Article 2145a, as contained in article 5838 of the said Revised Statutes, is repealed.

4. Article 2147 *a*, as contained in article 5839 of the said C. C., 2147a Revised Statutes, is replaced by the following : replaced.

“ 2147a. The notices, declarations and memorials mentioned in articles 2026, 2098, 2106, 2107, 2111, 2115, 2116, 2120, 2121, 2125, 2131, 2132, 2133, 2136, 2146, 2161, 2168 and 2172 may be given either under private seal or by notarial deed *en minute* or *en brevet*. How certain notices, &c., may be made, &c.

“ Such notices, declarations or memorials, if *en brevet* or under private seal, must remain in the registry office, but if *en minute* the delivery of an authentic copy is sufficient. To remain in registry office.

“ The certificate of registration is affixed to such notices, declarations or memorials only if it be demanded.” Certificate in certain cases.

5. The second paragraph of section 1 of the act 47 Victoria, chapter 13, is amended by adding, in the third line, after the figures “ 2133,” the figures “ 2136,” and by striking out, in the third and fourth lines of the fourth paragraph of the said section, the words : “ provided the entries have been regularly made in the index to immovables.” 47 V., c. 13, s. 1, § 2 amended.

C A P. X X V I I .

An Act to amend article 2319 of the Revised Statutes of the Province of Quebec, respecting the residence of the judges.

[Assented to 21st March, 1889.]

WHEREAS it is expedient to amend article 2319 of the Revised Statutes of the Province of Quebec ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows : Preamble.

1. Article 2319 of the Revised Statutes of the Province of Quebec is amended by striking out the words “ ten of the judges of the Superior Court shall reside ” at the beginning thereof and replacing them by the following words : “ eleven of the judges of the Superior Court, one of whom to be specially charged with the district of Terrebonne, shall reside.” R. S. Q., art. 2319 amended. Residence of certain judges
