3. The following article is added after article 3236 of the said Statutes :

3236a. The preceding articles of this chapter do not apply to the contracts existing on the ninth of May, 1885, except in the provisions thereof which are consistent with the usual interpretation of contracts, which shall be executed according to their form and tenor.

denied by con-

Nevertheless, to avoid all misunderstanding, the admission, the discharge on trial and the discharge of patients, the visiting and examination of such patients, their transfer from one asylum to another when such transfer is not forbidden by the contract, the control of the medical service, when such control is not denied to the government by the contract, shall still remain with the government and its officers.

An Act to amend the law respecting interments and disinterments.

[Assented to 21st March, 1889.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The following article is added after article 3465 of the Revised Statutes of the Province of Quebec :

Depth of earth
over coffin.

“ **3465a.** But whenever death was not caused by any of the diseases mentioned in article 3463, the coffin shall be covered by at least three feet of earth.”

R. S. Q., art.
3466 replaced.

2. Article 3466 of the said Revised Statutes is replaced by the following :

3466. No interment is allowed in private vaults, unless, whatever may have been the disease which caused the death, the coffin be deposited in a grave and covered with four feet of earth, or incased in masonry of at least twelve inches in thickness if in stone, or of at least eighteen inches in thickness if in brick ; both stone and brick being well covered with mortar.

Burials in private vaults.

The coffin may also be placed on shelves or trestles, in vaults, provided that the body be placed in a metal coffin hermetically closed."

Certain coffin may be placed on trestles, &c

3. The following article is added after article 3485 of the said Revised Statutes :

Art. added after R. S. Q., art. 3485.

3485a. No disinterment of more than one body at a time shall be allowed between the first day of June and the first day of September unless for the purposes of the administration of justice."

No general disinterments allowed between certain dates.

4. This act shall come into force in the day of its sanction.

C A P. X X X V I I .

An act to amend the law respecting the Bar of the Province of Quebec.

[Assented to 21st March, 1889.]

HER MAJESTY by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Articles 3505, 3506, 3514 and 3523 of the Revised Statutes of the Province of Quebec are amended by adding in each the word " Ottawa " after the word " Arthabaska."

2. Article 3537 of the said Revised Statutes is amended by adding after the words " Three-Rivers " in the first paragraph thereof the word " Ottawa ".
