

CAP. CXIV.

An Act to authorize the Bar of the Province of Quebec to admit Fergus Murphy among its members after examination.

[Assented to 21st March, 1889.]

Preamble.

WHEREAS Fergus Murphy, of the city of Quebec, has by his petition represented : that he has studied law from November, 1882, up to date, under William Cook Q. C. and Archibald H. Cook, advocates, of the city of Quebec ; that although he has studied under the above named patrons, as established by their certificate, for a longer term than the law requires, he cannot legally be admitted to practise law by the Bar of the Province of Quebec, inasmuch as he has neglected to pass the examination for the admission to the study of the profession ;

Whereas he has prayed that the Bar of the Province of Quebec be authorized to admit him to practise the profession, and whereas the majority of the members of the council of the Bar for the section of Quebec have approved the petitioner's application ; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Bar of the Province of Quebec may admit the said Fergus Murphy as an advocate and attorney and admit him to the profession of advocate, as soon as he shall have passed the examination required by the law respecting the Bar of the Province of Quebec in the terms of articles 3544 and following of the Revised Statutes of the Province of Quebec.

2. This act shall come into force on the day of its sanction.

CAP. CXV.

An Act to authorize the Bar of the Province of Quebec to admit Lawrence Lynch among its members after examination.

[Assented to 21st March, 1889.]

Preamble.

WHEREAS Lawrence Lynch, of the city of Quebec, has, by his petition, represented that he has studied the law as clerk in the office of a practising advocate for a period of fourteen years and is able to pass the usual examination for admission to the practice of the profession

but omitted to enter into the indenture of clerkship required by law, and is now desirous of an act being passed enabling the Bar of the Province of Quebec to admit him to the profession ; and whereas the Council of the Bar of the district of Quebec has, by a resolution, adopted on the seventh day of January, eighteen hundred and eighty-nine, approved of the application of the said Lawrence Lynch, and whereas it is desirable to grant the prayer of the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Bar of the Province of Quebec may admit Lawrence Lynch among its members and authorize him to practise the profession of advocate, so soon as he shall have passed the examination required by the act respecting the Bar of the Province of Quebec for admission to the practice of the said profession.

L. Lynch, may be admitted to Bar after examination.

2. This act shall come into force on the day of its sanction.

Coming into force.

CAP. CXVI.

An Act to authorize the admission of Joseph Edmond Gustave Lemieux, of the city of Quebec, to the study of dentistry.

[Assented to 21st March, 1889.]

WHEREAS Joseph Edmond Gustave Lemieux, of the city of Quebec, has gone through a course of classical studies, and has been unable for weighty reasons to present himself for the examinations for admission to study of dentistry, but has studied that branch of medical science ; whereas his not having been regularly admitted exposes him to great damages ;

Preamble.

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The said Joseph Edmond Gustave Lemieux is authorized to study dentistry, as if he had passed the examinations and obtained the certificate required under article 4063 of the Revised Statutes of the Province of Quebec, and to enter into indentures accordingly.

J. E. G. Lemieux authorized to study dentistry.

2. This act shall come into force on the day of its sanction.
